8. Business Items:

- 1. Proposed Changes in the UFS Bylaws (Ron Nyhan)
- 2. School of Criminology and Criminal Justice has rescinded its proposal to require majors to have a 2.5 GPA
- 3. Report on meeting to discuss suspending changes to policy limiting instructors as Principal Investigators.
 - -Barry Rosson said that the policy was made to comply with a request from a consulting body and that the policy was made before his time as interim Vice President for Research. He said that the Research Committee was not consulted to make the policy.
 - -Fred Hoffman asked if they could just get it approved by the research committee and bring it to the senate.
 - -Barry Rosson said that they could do that.
 - -Jerry Haky said that there are several titles that need to be added.
 - -Fred Hoffman asked why the committee isn't the one deciding the wording.
 - -Michelle Hawkins said that she finds it uncomfortable to be the PI for an instructor that knows more about the subject than the person who must be on the project, as if it is demeaning to the instructor.
 - -Dr. Lenz is going to inquire with Barry Rosson as to whether he is going to send the policy to the research committee and what the status of the policy will be until then.
- 4. Results of the National Survey of Student Engagement.
- -Tim Lenz reported that the December BOT meeting included pointed criticism of the status quo with constructive criticism of students (specifically admission

standards), the administration(specifically policies such as enrollment strategies and policies)cy and faculty (specifically the lack of engagement in efforts to improve FAU data on retention, graduation, etc. The discussion was prompted by a presentation of the results of a national survey of students. There was an extended discussion of this and other surveys and data on institutional performance, including

the allocation of increased resources to support the changes expected, and measures of faculty engagement.

- A senator proposed forming a committee to look at the data gathered to assess the effectiveness of the university and form positive recommendations. After discussion of ways to provide the Strategic Planning Committee with input, there was asuggestion that Steering discuss creating a committee and bring the issue back to the Senate next month.

10. Open forum with the Provost

-Diane Alperin reported that the President is discussing the student survey and related issues, noting that it is important to take into consideration FAU's institutional characteristics when discussing comparative data.

She also reported on sabbatical awards. Sixteen one semester sabbaticals were awarded.
