#### **c.** Performance Metrics Discussion

- o Moving forward, FAU has considered block tuition and the Florida Legislature is currently in discussion as well. Block tuition would reduce the price of credit hours for students and give students the opportunity to graduate within four years.
- Finally, Jeff Atwater, Chief Financial Officer of Florida will become the new Vice President of Finance for FAU.
