University Faculty Senate Meeting Minutes April 25, 2022 Webex, 1:00PM – 3:00PM

- **1.** The UFS meeting was called to order by Dr. Kim Dunn at 1:00pm. The meeting was held on Webex.
- **2. With positive approval**, the Senate approved March 25, 2022 UFS Minutes.

3. President's Report

- a. Dr. Kim Dunn states the election results (please see attached).
- b. Dr. Dunn states that Dean George will be chairing the Provost Search Committee. She sent out an email that listed all of the committee members. Candidates won't be here until the fall semester. Faculty will have a voice in the Provost's search. Dr. Hawkins will be the Interim Provost. We will also be celebrating Provost Danilowicz.

4. Speakers

- a. Linda Johnson, Associate Vice President Campus Realignment Task Force
 - The campus realignment task force was charged with:
 - A) Optimize programs, personnel, and space to enhance overall enrollment, research, and service to our region.
 - B) Recommend ways of increasing access to academic programs from any FAU campus.
 - C) Recommend which academic programs should be offered on which campus— primary and secondary location(s)
 - D) Recommend research programs and core facilities campus location—primary and secondary location(s)
 - E) Recommend student and campus services to be available on each campus and mechanism of delivery (e.g., in-person, remote, blended) as applicable.
 - F) Recommend which support services (back of the house) may relocate to a partner campus to free up space on the Boca Raton campus for instruction or research as/if needed. They were organized into five committees: 1) Academic Programs Linda K Johnson, Chair, 2) Research and Core Facilities Dr. Karin Scarpinato, Chair, 3) Student and Campus Services Tracy Boulukos, Chair, 4) Space Utilization Dr. James Capp, Chair, and 5) Task Force Reporting and Branding.
 - Findings were included in the presentation of each campus.
- b. Wendy Ash Graves and Jaeson Weber Covid-19 Updates
 - Given the widespread availability of vaccines and treatments, and in consultation with public health officials, FAU is ending its COVID-19 protocols. The effective date of this change is Friday, May 6.

- From this date, employees and students no longer need to report a positive test or symptoms to Student Health Services. FAU will now treat COVID-19 similar to other contagious viruses while monitoring all public health concerns that might necessitate an immediate response.
- If you are sick, stay home (<u>COVID-19 symptoms</u>). Anyone who tests positive for COVID-19 or is in close contact with a confirmed case of COVID-19 should follow the <u>Centers for Disease Control and Prevention</u> (CDC) quarantine and isolation guidelines or the advice of their treating physician. <u>Testing locations</u> remain available throughout the county and state of Florida.
