Presidential Memorandum #56 Emergency Policy

Establishes policy for the implementation prior to, during, and following a major emergency or disaster such as hurricane, tornado, earthquake, flood, fire, sink hole, hazardous or nuclear material release, epidemic, long term power outage, civil disorder, and criminal threats.

This policy becomes effective when a disaster occurs that is not covered by an Executive Order but requires the closing of one or more buildings on one or more Florida Atlantic University campuses.

Presidential Memorandum #56 Emergency Policy

Policy requires the Executive Committee to establish specific procedures that define personnel authorities and responsibilities during all phases of an emergency (mitigation, response, and recovery).

These procedures must be updated and practiced, at least annually, for maximum effectiveness.

Continuity of Operations Plan (COOP)

Florida Statute 252.365 and Florida Law Chapter 2002-43 establishes requirement for COOP by July 1, 2003

Plan for sustaining <u>essential</u> (not all) functions and operations for 30 days

They are for everyone:

Units and Departments
Campus-wide
University-wide

Continuity of Operations Plan (COOP)

Consists of 12 elements:

- Plans and Procedures
- 2. Mission Essential Functions
- 3. Delegation of Authority
- 4. Orders of Succession
- 5. Alternate Facilities
- 6. Inter-Operable Communications
- 7. Vital Records and Databases
- 8. Logistics and Administration
- Personnel Issues and Coordination
- 10. Security
- 11. Testing, Training, and Exercises
- 12. Program Management

Presidential Memorandum #85 University Safety Policy

To provide and ensure a safe and healthy environment for employees, students, and visiting public by maintaining, at all times, an effective safety program.

Administration and management shall sponsor and support all safety procedures, training, and hazard elimination practices.

Environmental Health and Safety (EH&S) in conjunction with FAU Administration is responsible to evaluate all health and safety considerations on all campuses of the University.

Presidential Memorandum #85 University Safety Policy

Each person in a supervisory or management capacity is responsible for the provision and maintenance of safe working conditions in their respective area and for proper dissemination and enforcement of all applicable rules and regulations.

Each employee and student is personally responsible to know and comply with safety rules (in the capacity that these are applicable) and to use only the accredited safety equipment that is provided or required.

There is continual review of the effectiveness of all the current health and safety programs for compliance with applicable rules and regulations.

University Safety Committee

The University Safety Committee (USC) is mandated by the President of Florida Atlantic University, to guard for the health and safety of all students, faculty, staff, visitors and the environment, and to comply with all applicable local, state, and federal regulations.

The purpose of the Committee is to provide a forum for the University Community to identify and to resolve safety-related issues; to identify, analyze, propose solutions to hazardous situations, and subsequently advise Environmental Health &Safety (EH&S) and Administration of its findings and recommendations.

Meetings are on a quarterly basis or more frequently if needed.

Comprehensive Emergency Management Plan (CEMP)

Multi-hazard basic plan for emergencies or disasters whether <u>natural</u> or <u>man-made</u>.

Intended as framework for university wide:

Mitigation

Preparedness; including preplanning training drills

Response

Recovery activities

Comprehensive Emergency Management Plan (CEMP)

Underscores the functional responsibilities incumbent upon the University divisions and departments, including providing qualified staff for the missions.

Defines the essential support functions required for continuity of operations.
