

# Full Board Meeting Minutes Tuesday, April 21, 2020 – 10:00 a.m. VIRTUAL MEETING

## I. Call to Order and Roll Call

Chair Abdol Moabery convened the full board meeting of the Florida Atlantic University Board of Trustees with the following members participating:

Roll was taken and a quorum was present.

## II. Chair's Report

Chair Moabery opened by thanking the FAU administration, faculty and staff who are working tirelessly to help keep the university running. He also thanked the federal government for its help through stimulus funding.

Chair Moabery noted that this was the last meeting of Student Government President Kevin Buchanan. He thanked him for his time on the board and for his advocacy for the students.

## III. President's Report

President Kelly opened that we received a share of the federal CARES Act funds for universities. The good news is that FAU will end the year in the black. The university is in daily contact with the Board of Governors (BOG) and the other State University System (SUS) institutions. Dr. Kelly went over the new appointees to the BOG chair task force on reopening.

Dr. Kelly noted that FAU has just passed the halfway point on our Race to Excellence Strategic Plan. He asked VP of Research Dan Flynn to go over the new grant awards and proposals submitted. Dr. Kelly said that faculty member Peter Ricci's online hospitality management initiative is teaching over 57,000 students from 43 countries. This course is free to anyone in the hospitality industry.

FAU's faculty and staff have donated many of their leave hours to help with those that need it. Dr. Kelly showed the board the face coverings that are being made by FAU to help hospitals and healthcare professionals. Videos from the Christine E. Lynn College of Nursing, the Today Show and the athletic department were shown.

Dr. Kelly said Vice President Danita Nias is in constant contact with our donors to continue our strong relationships.

Dr. Kelly thanked Chair Moabery and Trustee Dennis for their generous gifts to the university.

Dr. Kelly noted that collaboration is key right now. The strategic task force that he appointed to review the fiscal effects of the COVID-19 crisis will be focused on making the right decisions and nothing is off the table.
