## **Professional Certification Courses**

# Applied to the Statement of Eligibility

To use this guide, each student must have a Statement of Eligibility (SoE) from the Florida Department of Education. Please visit <a href="www.fldoe.org">www.fldoe.org</a> or call 1-800-445-6739. The SoE provides the student with a customized list of the requirements they must complete to be issued full state certification in Florida. Using the SoE, the guide below identifies courses available at Florida Atlantic University for those students looking to satisfy areas identified on the SoE as required.

### Notes:

- A minimum of 15 semester hours in education courses with credit in each of the professional education areas listed above is required.
- One professional area MAY be satisfied by one year of teaching experience in a classroom. The SoE will designate this allowance, if applicable. Teaching experience cannot be used to meet the requirement for teaching LEP students, and will probably not be approved to meet RED 4335.
- A passing grade of "C" or better must be earned for each course.
- Every course must be completed at an institution that awards bachelor's degrees or higher.

The guideline for those presenting an SoE processed prior to January 2016 differs from the current rule. Please see the table below for guidelines when a student presents an SoE dated prior to January 2016, yet still within the 3-year window prior to expiration.
