FLORIDA ATLANTIC UNIVERSITY DISASTER AND EMERGENCY SERVICES ADDENDUM

This Disaster and Emergency Services Addendum is a part of any agreement, services, or purchase order pertaining to disaster and emergency services ("DE Services") being provided to Florida Atlantic University ("University"). DE Services include, without limitation, any professional and/or technical services required by the University in the preparedness, response, recovery and mitigation phases of any natural or man-made disaster or emergency situation.

All providers providing DE Services to the University ("DE Service Providers") must abide by the Federal Emergency Management Agency ("FEMA") and the State of Florida Public Assistance Program requirements and work in cooperation and communcation with University administration and any disaster management consultant(s) employed or retained by the University. These requirements are critical in ensuring that the University will be considered an eligible applicant should public assistance be made available.

All DE Services and DE Service Providers shall comply with the following provisions and standards, as applicable:

- Equal Employment Opportunity E.O. 11246
- Affirmative Action 41 C.F.R. §§ 60-1.4(a), 60- 300.5(a), 60-741.5(a), 61-300.10, Executive Orders 11246 and 13465, and Appendix A to Subpart A of Executive Order 13496
- Clean Air Act (42 U.S.C. 7401 et seq.) and the Federal Water Pollution Control Act Executive Order 11738 and EPA regulations 40 CFR 15.
- Byrd Anti-Lobbying Amendment (31 U.S.C. 1352)
- Debarment and Suspension (E.O.s 12549 and 12689)
- Energy Policy and Conservation. P.L. 94-163; 42 U.S.C. 6201-6422
- Procurement of Recovered Materials. Section 6002 of the Solid Waste Disposal Act.
- Waste Disposal Act. Section 6002 of the Solid Waste Disposal Act
- Rights to Inventions Made Under a Contract or Agreement. 2 C.F.R. 200 Appendix II [F]
- General Procurement Standards, 2 C.F.R. Section 200.318
- Competition, 2 C.F.R. Section 200.319
- Procurement Methods and Requirements incl. 2 C.F.R. Sections 200.320 through 200.326

In addition to the above, the following provisions shall apply with regards to DE Service Providers performing DE Services involving construction or repair:

- Copeland "Anti-Kickback" Act (18 U.S.C. 874 and 40 U.S.C. 276c
- Davis-Bacon Act, as amended (40 U.S.C. 276a to a-7
- Contract Work Hours and Safety Standards Act (40 U.S.C. 327-333)

In the event of an inconsistency between any written agreements or purchases orders for the DE Services and this Addendum, the provisions of this Addendum will govern.
