Proposal- Certificate in Postsecondary Academic Coaching

Over the past two years, the Department of Counselor Education—specifically the School Counseling Track faculty—have been working with the Office of University Advising, the Undergraduate Dean's Office, and the Provost's office to incorporate elements of the *Student Success Skills* curriculum that has been developed and implemented at the K-12 levels. At this point, it is being expanded to a K-16 model, and we are looking to increase access for students and professional staff who are looking to increase their skills in the areas of advising that are primarily behavioral and emotional in nature (though sub-clinical), and moving students towards strategies that will help them meet their personal and academic goals. In the latest draft of the 2016 Accreditation Standards, CACREP (our accrediting body) accredits full programs in this area, called "Postsecondary Counseling."

While we are not prepared to offer a separate degree in "Postsecondary Counseling" we would like to offer a Certificate in Postsecondary Academic Coaching. This would consist of two courses currently offered in our program: MHS 6430 Career Counseling and MHS 6428 Lifespan Development. In addition, we would like to offer four additional courses:

MHS 5340 College Readiness, Engagement, and Success Skills

MHS 5401 Principles of Postsecondary Academic Advising

MHS 5620 Organization and Administration of Postsecondary Academic Advising

MHS 5608 Helping Skills for Postsecondary Academic Advisors

These would all be graduate-level courses (we have submitted for course numbers). I am attaching the syllabi for each, as well as a "crosswalk" of CACREP Postsecondary Counseling standards that each course would address. They were approved by the whole department this week, and the dean is aware of our intentions. I am in the process of securing letters of support from Joe Murray, Director of FAU's Office of University Advising, as well as from Peter Barbitas, Vice President of Student Services and Enrollment at Palm Beach State College attesting to the usefulness of such a certificate.

I am writing in support of the Certificate in Postsecondary Academic Coaching. Student success, persistence, retention and timely graduation have become critical for institutions within Florida and across the nation. State funding, performance evaluations and accreditations are becoming increasingly tied to all these efforts.

As an ongoing effort to develop policies and strategies to strengthen these efforts, there is a growing demand for academic advisors, career and success coaches, support personnel, student service professionals and administrators to increase their knowledge and credentials in the skills of academic coaching. Dear Colleagues:

This letter is written in support of Florida Atlantic University's proposal to create a certificate in academic coaching. As the role of academic advising has become more complex and more fully integrated with post-secondary institutions' strategic initiatives to improve retention and graduation rates, this presents a most timely opportunity.

Palm Beach State College is particularly interested in this proposal as we have committed to hiring 25 additional academic advisors over the next five years. Performance based funding will require us to be more holistic in our approach to not only monitor time to degree, but completion, job placement and starting salaries as well. As a result, we are aligning our career centers with academic advising and fostering a strong relationship with disability support services, mental health counseling and testing. In addition, a case management approach is being implemented by our advisors to create a stronger rapport with students and provide them with individualized support.

The College is further considering the addition of a third level on the career path for advisors which would require certification in career development, personal counseling or another national standard yet to be identified. The academic coaching certification would certainly be one of the credentials we would recognize.

We look forward to our continued close relationship with Florida Atlantic University.
