THE REQUEST FOR NEW LANGUAGE IN OUR ADMISSION REQUIREMENT FOR AS STUDENTS IS A RESULT ON OUR ACCREDITING BODY REQUIREMENT AT AS 3.2.3 THAT READS AS FOLLOWS:

AS 3.2.3 -BSW graduates entering MSW programs are not to repeat what has been mastered in their BSW programs. MSW PROGRAMS DESCRIBE THE POLICIES AND PROCEDURES USED FOR AWARDING ADVANCED STANDING. THESE POLICIES AND PROCEDURES SHOULD BE EXPLICIT AND UNAMBIGUOUS. ADVANCED STANDING IS AWARDED ONLY TO GRADUATES HOLDING DEGREES FROM BACCALAUREATE SOCIAL WORK PROGRAMS ACCREDITED BY CSWE, THOSE RECOGNIZED THROUGH ITS INTERNATIONAL SOCIAL WORK DEGREE RECOGNITION AND EVALUATION SERVICE, OR COVERED UNDER A MEMORANDUM OF UNDERSTANDING WITH INTERNATIONAL SOCIAL WORK ACCREDITORS.

THE FAU SCHOOL OF SOCIAL WORK DOES NOT HAVE AN MOU WITH ANY INTERNATIONAL SOCIAL WORK ACCREDITING AGENCY.

Foundation MSW students (part-time and full-time) participate in an inter-professional program with the Colleges of Medicine and Nursing that requires daytime hours. |
