## Section 2 Honors Faculty Members

At Florida Atlantic University, faculty members who teach courses in the University Honors Program should: possess a terminal degree and demonstrate a strong and ongoing commitment to promoting excellence in honors education through teaching, research, or service.

Faculty members who have taught previously in the University Honors Program and Honors in the Majors Programs can be granted Honors Faculty status upon the recommendation of the University Honors Council. The University Honors Council will review and certify Honors Faculty status to teach in the University Honors Program.

(NOTE: The administrator in charge of these courses should notify the University Honors Council whenever an exception is made, providing a rationale for the exception.)

All full-time faculty members whose primary college appointment is the Harriet L. Wilkes Honors College are granted Honors Faculty status.
