Academic Libraries Overview

Reason

The increased expenses include office furniture, television displays, remodeling and building repairs as well as library resources. Also, we had an increase in membership fees in 2019-2020 because we joined EAST (<https://eastlibraries.org/>). We paid \$28,430 in dues for EAST in 2019-2020.
