## University Faculty Senate Meeting Minutes April 19, 2013

1. The UFS meeting was called to order by William McDaniel, President, at 2:00 p.m. in the College of Nursing 201 on the Boca Raton Campus and video conferenced to Davie, Sea Tech, Fort Lauderdale, Harbor Branch and Jupiter.

2. Without changes, the Senate approved the minutes of the March 22, 2013 meeting

## 3. President's Report:

1. We need 10 volunteers to serve on the Senate's Athletics Committee. Also they become members of the Athletics Advisory Board. Give your name to Eric Shaw.

2. In the eight years that I have been Senator, I can't recall a report or meeting of the Academic Freedom & Due Process Committee. Now that a need arises, I revived it, starting about two weeks ago. I solicited, pushed and bullied such that now the Senate has an active committee that held its first meeting on Wednesday. They elected Marshall De Rosa as Chair. The first item they have started on is whether the principles of academic freedom are being violated in dealing with the "Step on Jesus" exercise and Dr. Deandre Poole. Per our Constitution "The Committee shall attempt to mediate voluntary settlement of all complaints. If voluntary settlement cannot be accomplished, the committee shall deliberate and issue a statement of its findings and recommendations." The committee is determined to proceed according to these steps: **a**. ascertain if in fact there is an FAU ban on the exercise and the textbook

**b**. ascertain what person[s] effected the ban

c. ascertain how much information the affected department has about the banning process
d. reach a judgment as to whether academic freedom has been breached and, if so, to what extent
e. if you find there has been a breach, try to reach an agreement [see constitution] as to how to ameliorate the breach and how to avoid repetitions as similar situations arise in the future
f. discuss how to deal the Governor's eagerness to influence class room delivery of material I observed the meeting. I judge the reps to be professors of extraordinary passion, depth and intelligence. They are very knowledgeable about academic freedom and are careful to determine facts before making judgment. The committee's preliminary finding is they have cause for serious concern due to an apparent breach of Academic Freedom. However, the committee needs time to do due diligence. Based on the preponderance of the limited evidence available, so far examined, there seems to have been a breach of Academic Freedom. Over the coming weeks and through the summer, committee members are conducting interviews with relevant people to

determine how it happened, who made decisions, who informed whom, etc. They pledge to have a full disclosure, if not a settlement, by the September Senate meeting. Because this is a standing committee, it may determine any other items that it should consider, consistent with its constitutional duties.

3. The Academic Planning and Budget Committee approved the proposed 2014-15 Academic Calendar, including two reading/storm days. It recommends the addition of another reading/storm day on the Wednesday before Thanksgiving.

4. I delivered our Senate GEO Stadium naming resolution via e-mail through Ron Bulger to President Saunders and Trustee Anthony Barbar the same Friday as the March Senate meeting. To assure that the message got to them directly before press or other outlets published it, the email made sense. I delivered the resolution in a formal hardcopy letter on the following Monday, again through Ron Bulger. Neither the President nor Trustee responded. At the BOT meeting on Tuesday, the resolution was alluded to only in passing by a couple of Trustees. Their statements, directed at the Senators who voted in favor of the resolution, were unfavorable. No Trustee made favorable statements about the resolution.

5. The final two or three months of my presidency have been times of unprecedented controversies at FAU. We've had some big controversies before, but never a series such as these. I perhaps abuse the privilege of having the floor as President by offering the following advice. Here I speak, not as President, but simply from the experience of FAU longevity and from being old. I see times where I failed to heed this advice, but I see that some students, some faculty, Senators and our administration were not applying the advice, much to FAU's detriment. Stealing from William Safire, who probably borrowed from someone else: in times of crisis, don't just do something ... stand there! He didn't mean it literally and I don't either. Instead of feeling a compulsion to act quickly – for whatever reason – think of the alternatives for dealing with the unfolding crisis. Try to think through all of the ramifications. Ask for advice from those you trust and from clear heads that are not directly affected by the situation. Emotional reactions are good starters to taking action, but careful logic and sober contemplation are more reliable finishers in taking action. After you think you have a very good course of action, wait – maybe even sleep on it. Then if the course of action still weighs to be a very one, go for it!

6. Technically, new Senate terms begin at this April meeting. I offer the new Senators my best wishes. I hope you will serve with President Nyhan as well or even better than the last two Senates served with me. I offer my hearty appreciation to all of you who have served along with me, and for whom this is the last meeting as a Senator. I laud your service.

7. Special thanks to the current Steering Committee for their excellent counsel and devotion to duty: Mort Levin, Marguerite Purnell, Michelle Hawkins, Eric Shaw, Valerie Bryan, and my

special confidants, Deborah Floyd and Ron Nyhan. Extra special thanks to Jennifer Govender, who has tackled the ASA job with extreme enthusiasm and competence. This gift will make it hard for anyone to fill her shoes. Last, my thanks to President Saunders and Provost Claiborne who are treating the office of Senate President with the respect it deserves, despite the eccentricities of its current short-timer occupant.

b) The Steering Committee strongly endorsed the revised FAU Policy on Acceptance of College Credits for Military Training and Education Courses drafted by the Admission and Retention committee. The Senate was in favor, <u>approved by majority vote</u>

#### 9. Speaker: None

#### 10. Open Forum with the Provost:

- The Provost thanked Dr. McDaniel for his service to the Senate and reminded the Senators to attend the farewell reception for Dr. McDaniel immediately following the Senate meeting.
- The Provost spoke about the budget. There are indications that the \$300m will be returned to the SUS institutions. She also spoke about her priority for the coming year which is merit raises and increasing new tenure and tenure track faculty lines.
- The chairs, Deans and Directors are in the process of submitting their requests for searches for next year
- The Provost would like to consider the request of replacement hires immediately.
- Wanted to focus her talk around the Deandre Poole incident and the issues that have come to the forefront over the past several weeks
- The Provost considers herself a faculty member first and therefore in her role as Provost she understands the need to represent the needs of the faculty.
- The Provost's main concerns are the individuals who have been directly involved with this incident, mainly Dr. Poole and the students.
- She has spoken with Dr. Poole over the last weekend and Dr. Coltman has been in constant contact with Dr. Poole
- Administrators and Staff have received thousands of threatening phone calls and emails which was documented and presented to the Steering Committee.
- She was concerned about the students in Dr. Poole's class so she attended Dr. Poole's classes with Dr. Coltman to gauge the concerns of the students
- For the most part, the students have moved on and were not offended by the exercise.

- The Provost affirmed that Academic Freedom will be supported and protected at FAU as one of the core values of this institution.
- The Governor has asked for a report on this issue and the newly formed Academic Freedom and Due Process Committee is investigating the incident.
- The Provost stated that all issues cannot be addressed at the moment
- She also stated her concern about safety issues at FAU and has now made a change in FAU procedure. She has requested that all police reports involving faculty and student incidents, be forwarded to the Deans and Provost Office within 24hrs of filing.
- She has requested Diane Alperin to serve as a rep on the Student Crisis Awareness committee which meets regularly to discuss events involving faculty and students.
- In moving forward, she sees many points of pride including faculty success and numerous scholastic achievements.
- She intends on hosting numerous forums and seminars for faculty over the coming months to engage in deep and meaningful conversations about issues that concern FAU.
- Asked faculty to help in this process of moving forward in how they can better protect and defend Academic Freedom and support faculty.
- In closing the Provost congratulated the faculty on their many achievements and thanked them for all their support and making it through trying times

# Questions from the Senate

- Dr. Chris Robe stated that he had looked into the issue and found that Dr. Poole did not violate his contract and that his academic freedom was compromised. The view of FAU by other professional institutions is that FAU does not support academic freedom. The Provost was asked to publicly state that she supports Dr. Poole's academic freedom and that his job will not be jeopardized. Other questions arose over the administrations untimely response to the incident right after the incident was reported in the media. The Provost commented that she has stated her position on academic freedom and that the AFDP committee was investigating and will submit a report on their findings.

# 11. Open Forum with the President

- The President commented that it was good to see the faculty especially at the end of a very tough year.
- The President spoke about the struggle to deal with the negative press and social media that has recently affected FAU.
- She honored the process put into place by the Senate to convene the AFDP committee to investigate the incident in Dr. Deandre Poole's class and would like to see the committee do its work to find a resolution to this issue.

- The President also stated that she supports academic freedom and understands the responsibility that comes with it because has she taught controversial courses in the past as a faculty.
- She thanked Dr. McDaniel for his work as President of the Faculty Senate and as a Trustee of the university.
- She also thanked the Provost for stating their position on their core values and understanding in protecting faculty and students and protecting the safety of the campus.
- She spoke about the hostile threats to the university and staff.
- The President spoke about the success of the faculty and students and thanked them for all their hard work and scholarship.

# **Questions from the Senate**

- Dr. Marshall DeRosa, chair of the newly formed AFDP asked the President if she could send out a memo to the administrators and staff who were involved with the incident, to cooperate with their investigation. The President responded that it was a very important task and she stated that she would ask the administrators to comply with the committee's request.
- Other questions were raised about whether upper administration supports academic Freedom and tenure and the principles of tenure.
- Faculty also wanted to know if there was fair representation of faculty and students in recent decisions
- Faculty are deeply invested in the university and are deeply concerned about their future especially since the upper administration does not listen to their voice.
- The regular operation of the university also needs to be urgently addressed.
- The President responded by saying that she and the Provost attended the Senate meetings to listen to the faculty and she also urged the faculty to participate more actively in the decision making process at the university meetings.

## **Good of the Senate**

- Mike Harris: There have been changes to the criteria for P&T that was never vetted through the Senate which is of major concern in the implementation of policies and who makes those decisions and why. President McDaniel is asking for P&T chair to report to Senate in September.

#### Proposed New FAU Policy

College credit will be granted to students with military training and coursework that is recognized by the American Council on Education (ACE), subject to institution transfer practices and limitations on amount, level, etc., of transfer credit. Military training coursework will be subject to the same treatment as any other transfer credit evaluated, with the utilization of the ACE *Guide to the Evaluation of Educational Experiences in the Armed Services* for determining equivalency and alignment of military coursework with applicable university courses. If the coursework fulfills a general education, or major course, and/or degree requirement, consistent with the college/department policy, the credit will be granted for meeting that requirement towards graduation. Applicable course credit may include free elective course credit towards the degree.
