Welcome to CCJ 4632: Elders in the Criminal Justice System! I am excited to be teaching this class and look forward to us having a lot of engaging discussions about how a rapidly growing aging population impacts our criminal justice system.

Course Description:

This course will utilize an interdisciplinary approach to examining the many ways in which elders interface with the criminal justice system. Topics covered include: the nature and extent of elderly crime, the criminal justice system response to older offenders, elders as participants in criminal trials, elders as victims of crime and abuse, and legal issues for elderly populations. Particular attention will be placed on assessing these issues from a policy perspective that incorporates concern for administrative, legal, and ethical issues.

Placement in Program: CCJ 4632 is an elective course.

Other Designations: A "C" or better grade is required in all Criminal Justice coursework being applied towards the degree, up to and including courses within the 42-credit maximum.

Time Commitment per Credit Hour: This course has 3 credit hours. For traditionally delivered courses, not less than (1) hour of classroom or direct faculty instruction each week for fifteen weeks (15) weeks per Fall or Spring semester, and a minimum of two (2) hours of out-of-class student work for each credit hour. Equivalent time and effort are required for summer semesters which may be offered over a shortened time frame. E-learning, hybrid, shortened, intensive format courses and other non-traditional modes of delivery will demonstrate equivalent time and effort.

You are expected to access the course at least three times per week to ensure you do not miss pertinent postings, messages, or announcements. It is imperative that you meet course deadlines and

stay active in readings, postings, etc. If you are experiencing major illnesses, absences due to university duties, or other large-scale issues, contact me immediately to formulate a resolution (if possible).

Course Learning Objectives

Upon successful completion of the course students will be expected to:

- 1. Recognize the demographic changes in our society and explain how a rapidly increasing older population will affect the criminal justice system.
- 2. Understand the nature and extent of crime committed by older adults.
- 3. Understand the nature and extent of elder abuse, mistreatment, and exploitation.
- 4. Explain the challenges associated with getting accurate statistics on elder abuse.
- 5. Distinguish the most common forms of elder abuse, neglect, and exploitation.
- 6. Interpret research findings on elders in the CJ system and discuss the policy implications

Course Delivery Mode

This is a **FULLY ONLINE** Class course accessible only through FAU's learning management system—Canvas. You must log into Canvas with your FAU ID and Password to access the materials and assignments in this course. The course is organized into weekly units with dates provided for each unit. The course begins with a **START HERE** unit that will familiarize you with the organization and navigation of the course. This is not a self-paced class -- new modules will open each week. For each week you will be required to complete readings and assignments. See the Canvas site for the details on course requirements and expectations.

Required Text

Readings will be made available through the class Canvas site. Students do not need to purchase any textbooks.

Class Participation and Netiquette

A quality learning experience in this course rests heavily on a high degree of interaction and exchange of ideas among all of us. Although this is an on-line class students are expected to actively participate in class activities. It is also expected that students conduct themselves in a professional manner. I will conduct this class in an atmosphere of mutual respect. Each of us may have strongly differing opinions on the various topics of class discussions. The conflict of ideas is encouraged and welcome. The orderly questioning of the ideas of others, including mine, is similarly welcome. However, I will exercise my responsibility to manage the discussions so that ideas and argument can proceed in an orderly fashion.

Due to the casual communication common in the online environment, students are sometimes tempted to relax their grammar, spelling, and/or professionalism; however, remember you are adult students and professionals—your communication should be appropriate. You are expected to use correct spelling and grammar and write in complete sentences when communicating via discussion boards or emails. Also, please note that in the online environment you do not have the advantage of voice inflection or gestures. As a result, sarcasm can come across very negative, so this form of communication should be

avoided. When conducting peer reviews, responding to classmates' posts or writing emails remember that you are responding to the ideas of the writer: keep your communication professional and on-topic.

Communication Policy

 - You are responsible for reading all announcements posted by the instructor. Check the course announcements each time you login to be sure you have read all of them since your last login session.
- Email Policy
 - Except for Saturdays, Sundays, and holidays, I will typically respond to messages within 24 to 48 hours.

Course Assignments

All assignments must be properly submitted on Canvas by the assigned date and time. <u>Late</u> <u>assignments will not be accepted.</u>

- **Readings** We will be spanning a wide range of reading materials. The readings were chosen to stimulate discussion of ideological differences driving criminal justice policy. *Students are expected to complete reading assignments on time.*
- Exams/Quizzes There will be a total of three required exams during the semester (two during the semester and one during the final exam period) as well as periodic quizzes. *Make-up exams will only be given in rare and exceptional circumstances which have been approved by the instructor prior to the exam date.* Any student missing an exam (without an acceptable excuse) will receive a grade of "0" for that exam.
- **Discussion Posts and Critical Reflection Assignments** There will be periodic discussion questions and other brief writing assignments. Details regarding these assignments are provided in Canvas.

Taking Exams Online:

Respondus LockDown BrowserTM with Webcam will be required to take Exams in this course. Respondus LockDown BrowserTM is a secure browser for taking exams in Canvas. It prevents you from printing, copying, going to another URL, or accessing other applications during an assessment. Click on the link to take you to the Respondus LockDown Browser Student Guide.

Respondus LockDown Browser provides a custom interface for the Internet Explorer (Windows) or Safari (Macintosh) software that is already installed on the computer. It does not modify an existing copy of Internet Explorer or Safari, but rather, installs a separate program that will display a custom browser when it is started. Respondus LockDown Browser uses the same security features and service packs that are currently installed for Internet Explorer or Safari. - If the computer or networking environment is different than what was used previously with the Webcam Check and System & Network Check in LockDown Browser, run the checks again prior to starting the test
- To produce a good webcam video, do the following:
 - o Avoid wearing baseball caps or hats with brims
 - Ensure your computer or tablet is on a firm surface (a desk or table). Do NOT have the computer on your lap, a bed or other surface where the device (or you) are likely to move
 - o If using a built-in webcam, avoid tilting the screen after the webcam setup is complete
 - o Take the exam in a well-lit room and avoid backlighting, such as sitting with your back to a window
- Remember that LockDown Browser will prevent you from accessing other websites or applications; you will be unable to exit the test until all questions are completed and submitted.
