### I. ELECTION OF CHAIR, APPROVAL OF MINUTES AND ANNOUNCEMENTS

As this was the first meeting of the UUPC for the 2020-2021 academic year, a chair needed to be officially elected. Current Chair, Jerry Haky, expressed his desire to continue serving as he has for the past 14 years. The other UUPC members unanimously elected Dr. Haky to be UUPC Chair for another year, and thanked him for his continued service.

Chair Haky then asked for review/approval of the Committee's minutes from its last meeting, April 27, 2020. **The UUPC approved the minutes as written.** 

### II. OLD BUSINESS

## **Arts and Letters**

#### Communication and Multimedia Studies

AL Rep Thomas Stollar introduced Guest Shane Eason, Communication and Multimedia Studies, to discuss FIL 4613 that was postponed at the last UUPC meeting. Guest Eason shared a document that demonstrates the rationale for the increase in credits for the film course. He said the course includes the creation of a significant project, one that students could enter in competition for the annual Flamingo Film Festival (<a href="https://filmfreeway.com/FlamingoFilmFest">https://filmfreeway.com/FlamingoFilmFest</a>). The course, also an ASL course, will be crosslisted with a 4-credit graduate course with the same title. The UUPC agreed with the rationale and approved the increase in credits.

#### Languages, Linguistics and Comparative Studies

AL Rep Stollar requested that discussion of the Minor in German be postponed until next month. No LLCL representative was in attendance to address the issues. **The UUPC approved postponing this item until the next meeting.** Chair Haky informed the group that this is the third time the item is postponed. If it is not approved at the October meeting, it will be automatically withdrawn.

#### III. NEW BUSINESS

### 1. University-Wide

## **Enrollment and Awarding of Certificates**

Registrar Brian Hodge explained that the proposed policy would ensure timely recording of certificate credentials, establish a recency of credit for courses used toward a certificate program, and establish a maximum number of transfer credits, if necessary. Currently, the policies surrounding certificate programs are vague; this new policy would provide standards that do not now exist. Several questions were asked, including why should more restrictions be placed on certificates, and how will the policy's 25 percent transfer credit rule affect students who took comparable courses, but can only transfer in 25 percent toward a certificate? Would those students be forced to take extra courses at FAU? The Committee shared that exceptions could be made, but Dr. Hodge explained that one of the main goals of the policy is to curtail the practice of former students requesting that a certificate be added to their record after they have graduated. This new policy was also presented at a recent University Graduate Programs Committee (UGPC) meeting and was approved. Following discussion, the policy was approved by the UUPC as well.

### Diversity, Equity and Inclusion

FAU's Provost Bret Danilowicz requested that the UUPC consider ways in which the University could satisfy the Diversity, Equity and Inclusion Initiative from the point of view of curriculum and prepare a recommendation for specific methods of achieving this. He suggested that possibly including language in each syllabus or developing a program or creating a set of learning outcomes could give students a clear idea of what FAU expects in terms of diversity, equity and inclusion. FAU's Student Government first suggested that through curriculum there could be a way for students to understand and embrace the University's position on the Initiative. During the discussion that followed, UUPC proposed the creation of a subcommittee to prepare a recommendation for Faculty Senate. Chair Haky stated that any UUPC member wishing to participate should send an email expressing their desire. Provost Danilowicz summed up his presentation by charging the UUPC to have a recommendation brought to Faculty Senate by the Senate's November meeting.

## **Foundational Course Requirements for New Students**

Dean Ed Pratt, Undergraduate Studies, presented a new policy encouraging new students, whether freshmen or transfer, to complete their foundational courses with the first two years of their academic career. Too often, students let these requirements lag until their final semesters, leading to problems in graduating on time. He added, this policy would be enforced by the advising offices, and it is important that it be added to the books to serve as a reminder for students. **The UUPC agreed and approved the new FAU policy.** 

### Thematic Clusters for IFP

Dean Pratt outlined a new way to offer FAU's Intellectual Foundations Program (IFP) courses (General Education). This initiative does not delete any of the current IFP courses or change the existing format for IFP, but rather adds a new offering that will make IFP courses more interesting and engaging for students. Students will be able to take IFP courses through thematic clusters that focus on a specific topic, such as Climate Change, Evolution, Technology and Society, Research and Inquiry, Race and Racial Equality, and Global Studies. This is currently running as a pilot program. Undergraduate Studies would like to make it effective Fall 2021.

There were questions regarding whether or not there were enough courses currently to populate the thematic clusters. Dean Pratt answered that if a particular theme or cluster does not have enough courses (the recommended three-to-six per cluster) that theme would not be offered. He added that a few courses in several of the topics are being added to the IFP to round out the offerings. Students must

take three courses in a cluster to complete the cluster. Chair Haky asked if recognition would be given to students for completing these clusters. Dean Pratt replied that decisions on recognition are still in the works.

Dean Pratt asked for the Committee's vote on the general concept of the thematic clusters and for approval on how the courses in the clusters will be presented/voted on by UUPC. He indicated that the Core Curriculum Committee will review cluster courses to ensure six-to-eight components of the course relate to the cluster theme. Then all courses comprising a cluster will be submitted to the UUPC with their syllabi for the cluster to be approved. After some more discussion, the UUPC approved the thematic cluster general concept and the procedure for approval of the clusters and their courses.

#### 2. Arts and Letters

Guest Nicole Morse from Women, Gender and Sexuality Studies (WGSS) explained that the current undergraduate certificate in WGSS is evolving into a minor. She said that as a minor, the program would now qualify for financial aid and appeal to more students. With an effective date of Fall 2021, any students in the certificate program at that time would be switched to the minor and the certificate will be terminated. **The UUPC approved the change from a certificate to a minor.** 

A new IFP course was also proposed by WGSS. This course will be included in the IFP's Global Citizenship Foundation and will likely be part of the Climate Change Thematic Cluster. **The course was approved by the UUPC.**

### Computer and Electrical Engineering & Computer Science

Guest Mihaela Cardei opened the discussion by stating that the two new CAP courses (2500 and 4612) were related to the proposed Minor and Certificate in Artificial Intelligence. Guest Fred Hoffman objected to approving the new courses and the minor and certificate because the Mathematical Sciences Department had not been consulted. BA Rep Thevenot also objected and wanted the Information Technology and Operations Management (ITOM) Department in the College of Business to be consulted.

There ensued a discussion focusing on when or if other departments should be consulted before new courses and programs are proposed. Hanqi Zhuang, chair of CEECS, stated that he received word from Rainer Steinwandt, chair of Mathematical Sciences, that he approved the content of CAP 4612. Dr. Hoffman replied that such consultation was not included on the course form for CAP 4612 and there was no indication that Math was consulted for the other course or for the minor and certificate. Dr. Zhuang added only Engineering students would be taking these courses, but Dr. Hoffman replied that perhaps Math would be interested in these courses/programs for their students. Therefore, consultation is necessary. Due to the requested consultation with Math and ITOM, review/approval of the two new CAP courses, the new minor and new certificate was postponed until the next meeting. **The UUPC approved the postponement with 7 in favor and 1 opposed.** 

EG Rep Meeroff brought forward the two EGN courses, which are being changed to add the Research-Intensive component. **The UUPC approved the addition of the RI component for these.** 

Other new courses and course changes on the agenda not related to Artificial Intelligence were then discussed. No objections were raised. **The UUPC approved the remaining courses.**

He also presented the prerequisite change for STA 3173. **The certificate and course change were approved by the UUPC.**
