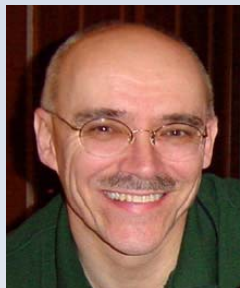

Dr. Orf received a B.S. degree summa cum laude in Chemistry from the University of Missouri - St. Louis, and A.M. and Ph.D. degrees in Chemistry from Harvard University. Prior to his appointment with Scripps, and since 1983, Dr. Orf served as Director of Molecular Biology Laboratories at Massachusetts General Hospital and Principal Associate in Genetics at Harvard Medical School in Boston.

Dr. Orf is a founder of and principal in Cambridge Laboratory Consultants, Inc., a consulting firm that has participated in the start-up of over 65 biotech companies in the greater Boston area over the past 25 years. Dr. Orf is also a founder and former board member of the Science Hotel at Cambridge, MA. Since arriving in Florida, Dr. Orf has been named to the Board of Directors of the South Florida Science Museum, the Florida Coalition for Improvement in Math and Science, the Florida Research Consortium, and BioFlorida, and was recently named Chair of the BioFlorida Committee on Education. He retired in September, 2004 at the rank of Colonel from the 804th Medical Brigade, US Army Reserves, where he recently spent a year on active duty serving with the Brigade in Iraq and Kuwait, and earning a bronze star.

She was re-elected in 1997 and again in 1999. During her first tenure in office, Susan served as Deputy Mayor from 1999-2000 and was Vice-Chairman of the Community Redevelopment Agency from 1996-1999. Ms. Whelchel was term limited in March of 2000 and was appointed by the Governor of Florida to a two-year term on the Palm Beach County School Board. Upon completing her term on the School Board, Whelchel was re-elected to the Boca Raton City Council in March 2003 and again in 2005, serving as Deputy Mayor for years 2003-2004, 2005-2006, and 2006-2007. Susan Whelchel has resided in the Boca community for over 30 years. She retains a BA degree in political science and has completed post graduate course work at FAU and Nova.
