SUBJECT: JOHN D. MACARTHUR CAMPUS MASTER PLAN AMENDMENT

PROPOSED COMMITTEE ACTION

Request:

Strategic Planning Committee to recommend BOT approval of the John D. Mac Arthur Campus Master Plan Amendment, dated September 10, 2008.

BACKGROUND INFORMATION

Pursuant to Subsection 1013.30, Florida Statutes, each university Board of Trustees shall adopt a campus master plan for the university and the Master Plan is to be updated every 5 years. In June 2007 the BOT approved the initial draft of the John D. MacArthur Campus Master Plan Amendment and authorized the Division of Facilities to proceed with the required public review process.

In August 2007 FAU held the first Public Review meeting and soon after distributed the draft Master Plan Amendment to the host and affected local government and public agencies. Upon receiving review comments, the draft Master Plan Amendment was updated to reflect and address all relevant comments. A second public hearing was held on September 10, 2008. With the completion of both public hearings and the incorporation of agency comments, the draft Master Plan Amendment is ready to be adopted by the FAU Board of Trustees.

IMPLEMENTATION PLAN/DATE

The Master Plan Amendment will be in effect once it is approved by the Board of Trustees and will address growth on the John D. MacArthur campus through 2015-16.

FISCAL IMPLICATIONS

Once the Master Plan Amendment has been adopted, FAU is to draft a proposed Campus Development Agreement and enter into negotiations with the Town of Jupiter to determine the impact of existing and proposed campus development reasonably expected over the term of the agreement.

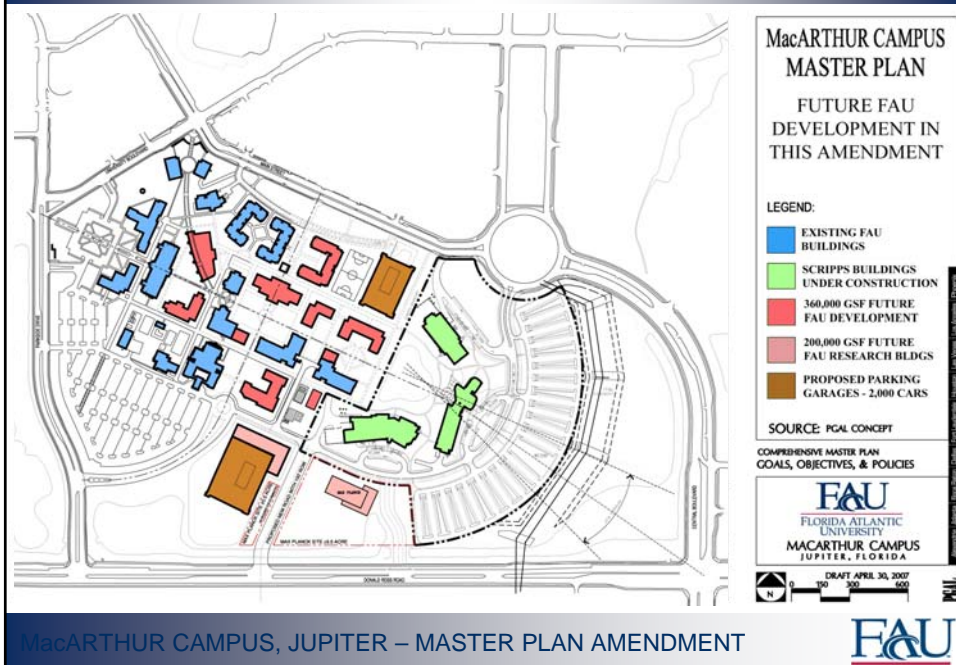
