SUBJECT: APPROVE NAMING OF UNIVERSITY ELEMENTS

PROPOSED COMMITTEE ACTION

Recommend that the BoT approves naming of the outdoor seating area outside of the dining hall, first floor, west wing of the AD Henderson University School/FAU High School Complex (the "ADHUS/FAU High School Complex"). The proposed name of the outdoor seating area will be the "Claussen Outdoor Commons."

BACKGROUND INFORMATION

Donation:

Jonathan Claussen and Allison Lane are donating Twenty-Five Thousand Dollars (\$25,000) for a recognition opportunity to name the outdoor seating area outside of the dining hall, first floor, west wing of the ADHUS/FAU High School Complex.

Gift Purpose:

The gift will be used to assist with the planning, financing, constructing, and equipping the ADHUS/FAU High School Complex, under the direction and within the discretion of the Assistant Dean of PK-12 Educational Programs.
