#### FA: A-M. Roll Call

### FA: I-1. Introduction to the Committee and Discussion

Trustee Ellison opened that he did not know much about the rankings when he came on the board. He is learning with help from the Provost's Office. Provost Michele Hawkins and Assistant Provost James Capp walked Mr. Ellison through some impressive data. He thinks the process that is in place is working. Mr. Ellison wants to dig into the numbers more with the trustees. He mentioned having a presentation given at the retreat in September and getting concrete steps ready for action.

Board Chair Levine added that FAU needs to focus on the items that will yield the greatest results to move up the ladder. Although the employers don't look at the ratings, the students are looking. He wants to see us in the top 100 of universities in five years.

Trustee Kim Dunn wants to be strategic in how FAU goes about doing this. She mentioned there are many prestigious schools not in the top 100. FAU can focus on certain programs to get into that category.

Trustee Dan Cane warned that just going ranking based to get better can mess with the organization of the university. Mr. Cane said that FAU should look at moves that both help the rankings and aligns with the bigger strategic mission of the organization.
