As a member of the Florida Atlantic University (FAU) community, you are receiving this email in connection with the University's continuing commitment to creating a safe learning and working environment where all members of the University community adhere to Title IX of the Education Amendments of 1972 as amended ("Title IX"). Title IX prohibits discrimination on the basis of sex and includes protections from sexual harassment and sexual violence under any education program or activity receiving federal financial assistance.

FAU takes any allegation of a violation of these regulations very seriously. In keeping with the University's responsibilities and compliance obligations, you are required to take the Title IX training offered through Canvas.

This course will help employees (staff, faculty, administrators, student-employees, etc.) better understand how to prevent and report sex discrimination, harassment or assault. This course will also help you recognize and respond to reports of sexual misconduct in accordance with applicable laws and university policies or regulations. Specifically, the online training applies to employees who are likely to receive information about sexual harassment or sexual misconduct.

The Office of Equity, Inclusion and Compliance (EIC) has primary responsibility for investigations, response to, and resolution of all reports of prohibited discrimination, harassment, and Title IX complaints.

Please be aware that any form of sexual harassment or sexual violence is prohibited by Title IX and is a violation of FAU Regulation 5.010, Anti-Discrimination & Anti-Harassment, which prohibits discrimination and harassment based on protected classes including sex.
