BACKGROUND INFORMATION

An Education Plant Survey (EPS) is required to be conducted once every five (5) years for all public educational entities. The survey for ADHUS Development Research School (DRS) was conducted by Department of Education staff on January 19, 2021. This survey recognizes ADHUS's new K-8 project, currently under design, and recommends on renovation, repairs, maintenance of existing facilities, as well as the need for a new STEM/Multipurpose facility.

A board approved survey recommendation is required for the release of PECO funds.

The EPS covers the period July 1, 2021 through June 30, 2026.

| Survey Annotation | Building 26, the main building (49,271 sq.ft.) at this school, had a Castaldi Analysis approved by DOE staff on September 22, 2014. FAU leadership is pursuing obtaining funding for a replacement building. In addition to replacing classrooms, administrative offices and the cafeteria in Bldg. 26, the new building will include a gym (or PE multipurpose room), auditorium, science and STEM labs, and additional classrooms to increase the capacity of the school. FAU's estimated cost for the new building is \$42 million. The new building will be built on FAU property adjacent to the current school site. Covered walkways – 200 If of added canopies at 10' wide includes cost for the foundations. 2,000 sf at \$37 = \$74,000. Drainage - around Middle School only. \$50,000. Site Development – Costs associated with razing and clearing site for parking and fencing in and around the perimeter of entire school, including gates. \$82,000. Other – Roofing for high school building. Building envelope is compromised and needs shoring up. 15,500 sf at \$20 sf = \$310,000. Other – Security fencing around the perimeter of the entire school to include gates. 4,100 If at \$20 = \$82,000. Other – New key system (hardware for 65 locks and doors) to tie in with existing. 65 at \$500 each = \$32,500. Other – Pool replacement – to include bleachers, canopies, etc. Cost \$1,025,960. Other - New 8 lane track – Approximately 5500 sy. No lighting included. Cost 5,500 at \$75 sy = \$412,500. Districtivide – Backup generator for middle and high school buildings. Additional or replacement of equipment for existing school buildings and to correct deficiencies relating to safety to life, health and sanitation. \$150,000. Upon completion of the New Construction, Portable 3 will be returned to the lessor and modular Building #28 will be returned to the manufacturer per their agreement. |
