

- Implemented a simplified system of tracking donor identification, qualification, cultivation, solicitation and stewardship

- Our funding priority projects are on track
- HBOI Indian River Lagoon Observatory unknown in the House, \$2m in Senate (champions are Debbie Mayfield, Larry Lee and Joe Negron)
- Tech Runway \$500k in House, \$1.39m in Senate (champions are Bill Hager, Lori Berman, George Moraitis and Maria Sachs)
- Jupiter Bioscience Initiative \$500k in House, 0 in Senate (champions are MaryLynn Magar and Joe Abruzzo)
- Lab school language and funding for inclusion in sparsity pot in both House & Senate (champion is Joe Abruzzo)
- Additional line items which pass through FAU
  - AMI experiential school \$1.5m in House through a contract with Pine Jog
  - Max Planck Scientific Fellow program \$1m in House


### **FAUF** Investment returns FY13
