SUBJECT: APPROVAL OF DEGREE TERMINATION – MASTER OF ARTS IN TEACHING IN ENGLISH

PROPOSED BOARD ACTION

Approve the termination of the Master of Arts in Teaching in English (23.0101).

BACKGROUND INFORMATION

The Master of Arts in Teaching in English has attracted a low number of students only graduating 3 MAT students in the past 6 years. The Florida Board of Governors recommends the termination of programs with low graduation outcomes. In addition, students incorrectly believe the degree will grant them a teaching certification which it does not.

IMPLEMENTATION PLAN/DATE

The program will cease admitting students as of the Spring 2016 semester. Currently there is only one student in the program with an expected graduation of Fall 2016.

FISCAL IMPLICATIONS

All existing courses will continue to be delivered, so the loss of the degree program will not result in a loss in faculty, courses or other resources.

The Department of English voted to eliminate the Master of Arts in Teaching (MAT) program for several reasons: 1) the program has attracted a low number of students (in the past 6 years, only 3 MAT students have graduated and there is only one student currently in the program) 2) the reasons for the inception of this program are no longer relevant and 3) many MAT students, despite warning to the contrary, believe that the degree grants them a teaching certification which it does not.

The program was originally developed on the Davie campus when Davie was a separate college and faculty could only participate in the Boca MA program by invitation. This is no longer relevant.

3. Provide an explanation of the manner in which the University intends to accommodate any students or faculty who are currently active in the program scheduled to be terminated. State what steps have been taken to inform students and faculty of the intent to terminate the program?

Currently there is only one student in the program with an expected graduation of Fall 2016. The student will continue in the coursework in the Spring 2016 semester and will either complete his thesis or take the exam option in the Fall 2016 semester. Because the MAT requirements did not substantially differ from the MA requirements, this student will be able to continue his path without any problems and either write a thesis or take the exam.
