Meeting Minutes of November 16, 2021

<u>GC: A-M – Roll Call and Approval for the February 16, 2021 Governance Committee</u> <u>Minutes</u>

Chair Bussani asked for approval of the February 16, 2021 meeting minutes. A motion was made and seconded to approve the February 16, 2021 Governance Committee meeting minutes. With no further discussion, the motion passed unanimously.

<u>GC: A-1 Approval of Newly Elected Director of the FAU Clinical Practice Organization, Inc.</u> <u>Board of Directors</u>

Mr. David Kian, VP of Legal Affairs, presented the item. Mr. Kian stated that the FAU Clinical Practice Organization (FAU CPO) is one of FAU's Direct Support Organizations (DSO). Each DSO has its own Board of Directors, however they exist for the benefit of the University and the University has significant oversight authority for each of them. One item of oversight includes the University Board of Trustees approving new members appointed to each DSO's Board of Directors.

Mr. Kian requested approval of re-appointment of Dr. Karethy Edwards to the FAU CPO Board of Directors. Dr. Edwards is the Associate Dean of Academic Programs and Professor for the College of Nursing and the Executive Director of the FAU Community Health Center located in West Palm Beach. A motion was made and seconded to approve the Newly Elected Director of the FAU Clinical Practice Organization, Inc. Board of Directors. With no further discussion, the motion passed unanimously.
