**SUBJECT: REQUEST FOR APPROVAL OF THE SECOND AMENDMENT TO THE CAMPUS DEVELOPMENT AGREEMENT BETWEEN FAU BOARD OF TRUSTEES AND CITY OF BOCA RATON**

### PROPOSED COMMITTEE ACTION

Recommend approval of the Second Amendment to the Campus Development Agreement (CDA) between FAU BOT and the City of Boca Raton.

### BACKGROUND INFORMATION

On November 18, 2009 the Board of Trustees approved the Campus Development Agreement between FAU BOT and City of Boca Raton to address the impacts created by the proposed development on public facilities and services, including roads, sanitary sewer, solid waste, drainage/stormwater management, potable waters, parks and recreation, and public transportation. The term of this agreement ends on December 31, 2015. The proposed second amendment to the CDA, extends the term of the existing CDA for an additional twenty four (24) months while FAU develops an updated Master Plan to align with the 2015 approved Strategic Plan – the Race to Excellence.

### IMPLEMENTATION PLAN/DATE

Effective upon final execution by both FAU BOT and the City of Boca Raton.

### FISCAL IMPLICATIONS

Continuing payment of monthly and annual obligations for stormwater, water, sewer and Tri Rail commuter shuttle services, if applicable.

This SECOND AMENDMENT ("Amendment") is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2015 ("Effective Date") by and between the CITY OF BOCA RATON ("City"), a municipal corporation of the State of Florida, and the FLORIDA ATLANTIC UNIVERSITY BOARD OF TRUSTEES, a public body corporate of the State of Florida ("FAU" or "FAUBOT").

WHEREAS, the City and FAU are parties to an Amended and Restated Campus Development Agreement dated November 24, 2009, as amended by a First Amendment dated November 2, 2012, pursuant to Section 1013.30(15), Florida Statutes (the "CDA");

WHEREAS, the City and FAU now desire to amend the CDA to mutually extend the duration of the agreement beyond the initial date of December 31, 2015.

NOW THEREFORE, on consideration of the covenants contained herein and the performance thereof, the parties do hereby agree as follows:

1. The foregoing recitals are true and correct and are incorporated as though fully set forth herein.
2. Article 5.0 of the CDA is hereby amended to extend the duration of the CDA for a period of two additional years, until December 31, 2017.
3. During the extension period, FAU shall continue to make all required recurring payments to the City for Stormwater Management Fees, Water and Sewer charges, and Annual Shuttle Payments, as applicable.
4. Except as specifically modified by this Amendment, all other provisions of the CDA shall remain in full force and effect and shall be binding upon the parties in accordance with their terms.
