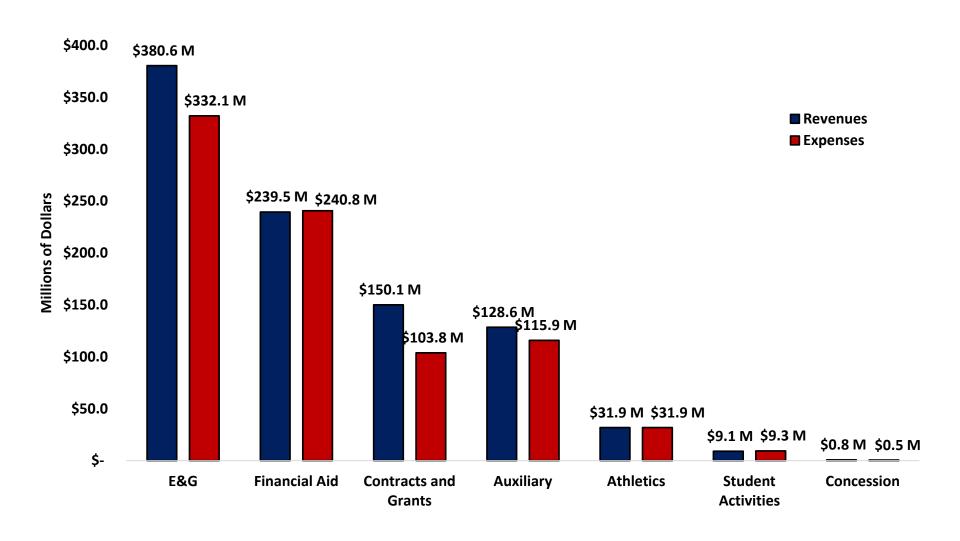

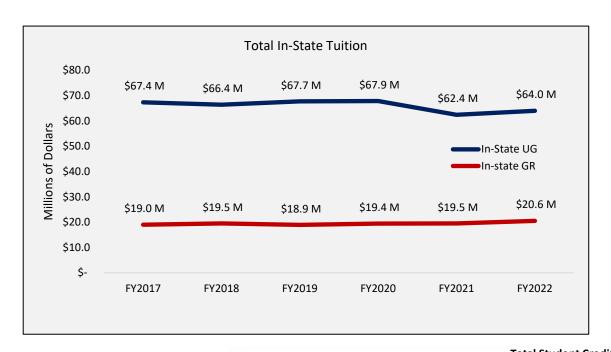
## FY22 Actuals-to-Actuals Revenues Compared to Expenses

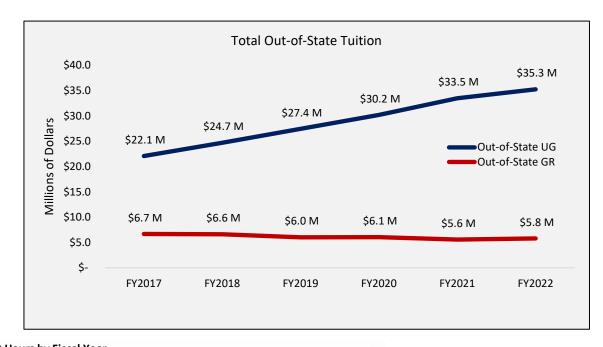

## Annual E&G Tuition by Student Residency



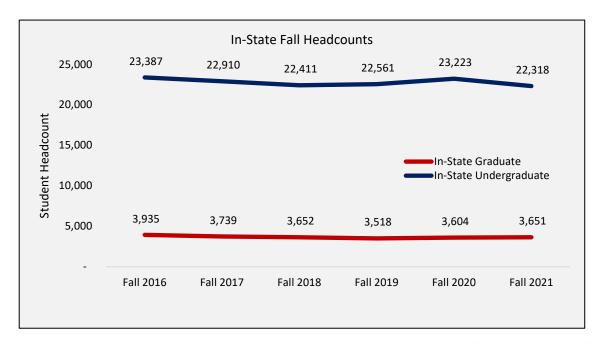


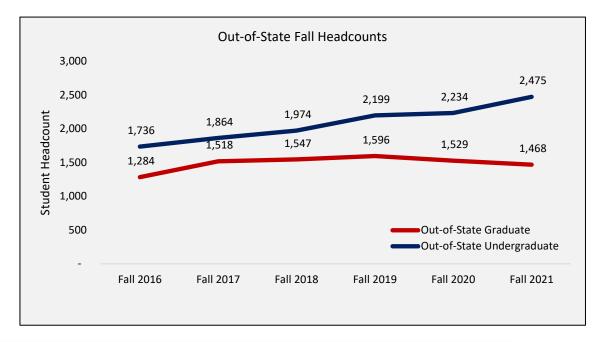

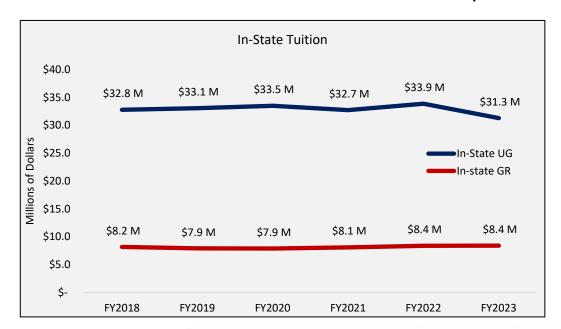

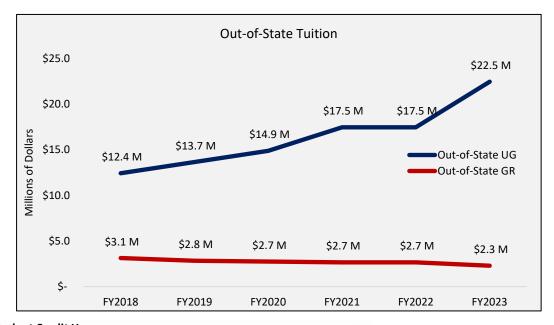
## Q1 E&G Tuition by Student Residency
