PROPOSED BOARD ACTION

Approve naming of the resource commons area, Rooms 113 and 146, within the proposed AD Henderson University School/FAU High School Complex (the "ADHUS/FAU High School Complex"). The proposed name of the resource commons area, Rooms 113 and 146, will be the "Bayardelle Family Commons."

BACKGROUND INFORMATION

Donation:

James Bayardelle is donating Twenty-Five Thousand Dollars (\$25,000) for a recognition opportunity to name the resource commons area, Rooms 113 and 146 of the ADHUS/FAU High School Complex.

Gift Purpose:

The gift will be used to assist with the planning, financing, constructing, and equipping the ADHUS/FAU High School Complex, under the direction and within the discretion of the Assistant Dean of PK-12 Educational Programs.

Donor's Background:
