*Whiskey Creek got its name during the prohibition era when rumrunners with illegal contraband would enter South Florida through this winding passageway. By the 1930's, Whiskey Creek came to be known as the "unofficial smuggler's capital of South Florida" and just west of the Creek smuggler camps have been found. Today Whiskey Creek is a beautiful, mangrove-lined waterway, where manatee sightings are not unusual. We will access Whiskey Creek from a sandy beach within John U. Lloyd Beach State Park.*
