
INTRODUCTION & EXECUTIVE SUMMARY**INTRODUCTION**

This document is the five year Master Plan update for the Boca Raton Campus of the Florida Atlantic University. The current Master Plan was adopted November 6, 2001 with a planning horizon of 2011. A Campus Development Agreement was negotiated with the City of Boca Raton in August 2002.

The new planning horizon for this update is 2016. This update includes discussion of both the growing Campus physical environment as well as the projected growth of the student body throughout the planning horizon. The current FTE enrollment projection for 2016 is 13,771 and the projected headcount for the same period is 23,852 students. This update is presented for review and comment by the public, the host city, Boca Raton, and other agencies in accordance with section 1013.30 of the Florida Statutes. This master plan consists of the 18 Elements, as outlined in the State Guidelines for the Campus Master Plan System. These elements include Goals, Objectives and Policies for their respective subject. Any supporting data that has been gathered or generated for this master plan is presented in the appendix of this document.

In addition to the 18 Elements, this master plan includes a 19th Element which encompasses the Boca Raton Community Hospital, a teaching hospital, which is being planned for in the southeast portion of the FAU Campus.

Figures MP.1 illustrates the amended campus plan, enumerating all planned building projects for the 10 year horizon. For clarity, MP.2 illustrates projects that have been added to the plan or were relocated since the 2001 adoption.

Other revisions to the existing Master Plan include housekeeping items such as:

- Removing references to former Board of Regents and replacing with Board of Trustees.
- Removing information pertaining to the Davie Campus, which has its own master plan.
- Adding completed buildings and altered roadways to the campus base maps.
- Updating storm water master plan.
- Revising square footages for some of the proposed projects.
- Updating maps with current infrastructure information.
- Updating the Capital Improvement elements.
