The Master of Social Work Curriculum change was unanimously approved by the committee.

SOW 6348, SOW 6605, SOW 6646, were unanimously approved by the committee. SOW 6655, was approved contingently upon the changing of the start/end dates on the first page of the sylabbi.

The program changes to Master of Urban and Regional Planning – Course description, Dismissal, Core Course Listing, Specialization, were all unanimously approved by the committee.

URP 6406 was unanimously approved by the committee, pending changes to the course schedule.

The program change to the MPA Admission Standards – GRE was tabled. The committee felt that it was unclear as to whether a student with lower than 3.2 would be considered. They wanted it to be more specific as to what would go into the catalog, and felt it was not clear as to what exactly was proposed.

NGR 6812 was unanimously approved by the committee

NGR 6110 was unanimously approved contingent with the submission of a bibliography.

The Program Change for Admission deadlines was unanimously approved with the clarification of the language of the date changes.

EDG 7251, PET 5930 were unanimously approved by the committee.

The Program change for Remote Sensing Certificate and RAT 6627 were withdrawn by the college. Both items needed too much clarification. It will be resubmitted to the GPC at a later date.

SAT 6177, MHF 6306, STA 6207, MHF 6107, and STA 6901 were unanimously approved by the committee.

The Program Changes for English MA and MAT, Certificate in Film Video, Graduate Certificate in Piano Performance and Pedagogy-Termination, Performance Concentration, Wind Conducting Option, and Masters of Arts in Communication were unanimously approved.

MUS 6205, and MUS 6206, were unanimously approved contingent upon the receipt of a grading scale in the syllabi.

CPO 6736 was unanimously approved by the committee.

BMS 6031, BMS 6032-termination, and BMS 6933-termination were unanimously approved by the committee.
