HOW TO APPLY FOR A FLORIDA DRIVER'S LICENSE FOR INTERNATIONAL STUDENTS F-1 AND J-1 VISA STATUS

You may either walk in make an appointment with the Florida Department of Motor Vehicles office. Following are the two locations closest to campus:

STEP 1: If you do not have a driver's license from your home country you must first take the **Traffic Law & Substance Abuse Education Course http://www.flhsmv.gov/ddl/TLSAE_providers.html**

STEP 2: Study the information in the Florida Driver's Handbook: http://www.flhsmv.gov/handbooks/

STEP 4: Go to the office with the following documentation:

- A. Valid passport
- B. Form I-20 (for F-1 students) or DS-2019 (for J-1 exchange visitors)
- C. I-94 printout
- D. \$48.00 processing fee (cash, credit card except Visa, check, or money order)
- E. <u>Two</u> of the following documents showing your address in Florida to confirm your residence. The following are acceptable:
 - 1) Educational institution transcript forms for the current school year
 - 2) Utility bills (cell phone, electric bill), not more than two months old
 - 3) Mail from financial institutions; including checking, savings, or investment account statements, not more than two months old
 - 4) Credit card statement
 - 5) A letter from our office confirming your local address

STEP 5: Take the exams:

- a) **Hearing** Drivers applying for a license who are deaf, or cannot hear conversation spoken in a normal tone of voice, are restricted to driving with an outside rearview mirror which should be mounted on the left side of the vehicle, or wearing of a hearing aid.
- b) **Vision** Vision testing, using an eye machine located on the counter, is conducted in all <u>driver license</u> <u>offices</u>. Visual acuity readings worse than 20/40 are referred to an eye specialist. Color blindness will not cause any special condition for licensing.
- c) Knowledge Exam 50 multiple choice questions about traffic laws and traffic signs.
- d) **Driving Test** You must provide a vehicle for the driving test. The vehicle must have a valid tag, proof of insurance, and pass a vehicle inspection. During the driving test, the examiner will observe your ability to control the vehicle and how well you obey traffic laws.
