Course Description

This course builds on ACG 2071 by helping students establish a working knowledge of cost accounting techniques such as job and process costing, cost analysis, cost volume profit analysis, cost allocation, budgeting, and variance analysis. This course also helps students understand how these techniques apply to managerial decisions. Whereas financial accounting courses focus on how accounting information is used by external stakeholders, this course focuses on how that information is used internal to an organization.

Course Prerequisites and Credit Hours

Credit Hours: 3 credits Prerequisite: ACG 2071 with a grade of "C" or better

Instructional Method

The Instructional Method for this class is designated **Fully Online Class**. As such, course content is delivered in an asynchronous format.

Course Learning Objectives

- 1. Describe basic cost accounting concepts and structure
- 2. Determine the costs of particular cost objects using job costing, process costing, and activity-based costing
- 3. Assist management in decision-making using cost-volume-profit analysis and other techniques
- 4. Conduct budget and variance analysis to help in the firm's planning and control function
- 5. Perform capital budgeting analyses

Course Format

This class is designated as distance learning. Course materials for each chapter are posted in Canvas (including recorded lectures). Students should:

- 1. Read the assigned chapter(s)
- 2. Watch and take notes on the chapter's video lectures (available in Canvas / Mediasite)
- 3. Take weekly multiple choice quiz (Pearson MyAccountingLab in Canvas)
- 4. Review lecture notes
- 5. Watch We Do video (illustration) and try the You Do problem (practice)
- 6. Attempt assigned exercises (Canvas)
- 7. Watch videos on assigned exercises (Canvas)
- 8. Complete Dynamic Study Modules (Pearson MyAccountingLab in Canvas)
- 9. Attempt additional homework in Pearson MyAccountingLab as needed
- 10. Use the study plan (Pearson MyAccountingLab) as needed

<u>Exams</u>. Exam questions focus on accounting concepts illustrated through classroom discussions and homework exercises. The exams are designed to extend your thinking through analysis and applications of these concepts in new or unique situations. The exam format may include multiple choice, problems, and short answer. Exam 4 is cumulative. Proctoring software may be used for online exams.

<u>Quizzes.</u> Chapter quizzes will be given using Pearson MyAccountingLab through Canvas and/or within Canvas itself. Quizzes are based on readings and/or homework and must be completed before the due date.

<u>Dynamic Study Modules</u>. Dynamic Study Modules are provided in Pearson MyAccountingLab for each chapter. DSMs help you check and improve your knowledge of material you must master to do well in your course.

<u>Homework</u>. Homework is assigned (see Canvas), but will not be collected or graded, although, there are graded quizzes on the homework. Additional exercises are also available through Pearson MyAccountingLab in Canvas. The exams will likely include questions based on the homework. It is strongly encouraged that students complete the homework on a timely basis. Students may want to work together on the homework to more fully understand the concepts.
