Hi Mihaela,

I agree it be OK to use the graduate new/change program form and list the programs indicating that the only change is to increase the shared credits from 9 to 12. Provide catalog changes for a sample program so that Steering and UFS can see how the changes would appear. I think since the language for all the combined programs is very similar, one example should suffice as long as all the programs being changed are all listed on the program change form or an accompanying memo if the list does not fit on the form.

However, if there are any combined programs that specifically list which courses are to be

shared, then those programs need separate paperwork: a separate program change form and catalog changes to show what the additional shared course will be.

Once the paperwork is complete, it should be submitted to Debra Szabo in the Provost's Office before it is placed on the agenda for GPC/UGC. Once Debra approves, then it can be submitted to the graduate programs committee and please cc me for the UUPC. The submission should include the approval email from Debra and approval emails from the colleges with which Engineering shares combined programs if those programs are being changed, such as Honors College and Nursing.
