ITEM III: CREATION OF THE COLLEGE OF ARTS AND LETTERS SCHOOL OF INTERDISCIPLINARY STUDY IN THE HUMMANITIES AND SOCIAL SCIENCES, AS PROPOSED BY ASSOCIATE DEAN FOR GRADUATE STUDIES.

Explanation:

For some time, the faculty of the college have made significant investments in interdisciplinary models of inquiry which has resulted in the development of several programs at both the undergraduate and

graduate levels. A fair number of these programs are not housed within traditional departments and, as a result, suffer from a lack of support that such departmental structures typically provide. In addition, those programs that are housed in departmental structures (WGSS and the PhD, for instance), benefit from close collaboration with other programs for the delivery of its curriculum, which requires significant collaboration and administrative support to effect. By housing these programs in the School of Interdisciplinary Studies, we hope to better facilitate student recruitment, identify and secure new development opportunities, foster integration and collaboration between these programs and those across the college and university more broadly, and increase the effectiveness of programs that attend to emergent needs and trends in higher education.
