 - Assembly Steering Committee needs a representative from partner campuses

 - Dawn L Rothe, First Vice President, and Nicole Morse, Second Vice President,
 United Faculty of Florida FAU
 - Collective Bargaining in progress
 - Next bargaining meeting September 24 to address Article 19 and Article 23
 - Sixteen of 30 articles have reached Tentative Agreement (TA'd) to date
 - Question on timeline for CBA: will not be complete before the end of October
 - Request to develop a new Memorandum of Understanding regarding COVID for fall 2021 was not entertained by administration
 - UFF-sponsored mask distribution continues in the FAU Breezeway
 - Petition and demonstration in front of Administration Building August
 17th
 - Petition was sent to President Kelly
 - Andrew Gother is now serving as the State President of United Faculty of Florida
- Dean Michael Horswell's Report, (11:59 a.m.) (no action)
 - Appreciation and thanks extended to:
 - The Assembly Executive Committee
 - Mauricio Almonte for completed service as Faculty Assembly Chair

- Area of Choral and Vocal Studies for the September 11 Remembrance Service in the amphitheater
- Theatre Lab for running a free show for young students, with physical distancing and masks worn by the audience.
- Organizers of Constitution Day celebration and events
- College Communications Office for producing event brochure, with all 13 units now represented
- Grant Applications
 - Over \$4 million in applications last year, up from \$1 million a few years ago. Thanks to Associate Dean Aimee Arias for effort in this increase.
- Largest year for college fundraising with \$27 million
 - \$20 million in one gift, \$15 million of which is in estate planning
 - A new facility will be constructed along the lake across from Garage 2
- Renovations to PA 101, downtown Ft Lauderdale, and the Ritter Art Gallery completed or in-progress
- Faculty research support from the college at record levels, with 100% renewal of travel support
- Dean's Budget Report (12:07 p.m.)
 - All of Academic Affairs is taking a 3% budget cut
 - Most substantial reallocation: \$11M to implement 'Workday Student' software
 - For the College of Arts and Letters, \$420,000 will be removed from the budget going forward
 - The college has 36 open lines accumulated over two years, including 15 incentive retirements
 - Individual colleges will now cover all faculty/ staff raises, including P&T,
 SPE, and CBA raises.
 - Arts and Letters has allocated \$900,000 to reserve for this
 - A new Chief Financial Officer/ Vice President of Financial Affairs has been appointed. Coming from Old Dominion University, an FAU peer.

 - Mauricio Almonte: Will ROCA and DEI committees be fully funded?
 - Yes. and increased.
 - Shane Eason: Are the presented spreadsheets available to review
 - No, due to complex nature of the data.
 - Mike Harris: Where did the idea of moving raises to each college come from?
 - Executive Leadership Team (ELT) worked this out.
 - Some discussion of the need for new revenue streams going forward, to help the college account for future % based salary increases.
