Brief

Rick is an Ivy league law graduate, well known investor, professor and successful lawyer. He lived in Palm Beach for many years, and he has been living on Jupiter Island. He’s been an FAUF donor since 2015 with gifts totalling \$4.1M (includes art work valued at \$3.8M) in the College of Business and the Schmidt College of Arts and Letters. His gifts have funded:

- **The Stone Initiative in Law, Economics and Business Fund:** support the work of professors in the College of Business.
- **Palm Beach Investment Research Group Scholarship Fund:** expendable scholarship fund to provide educational and research opportunities to students that are veterans, preference to business majors.
- **Rick and Lesley Stone Visual Arts Collection Fund:** early American art work valued at \$3.8M and support funding, including monies to help establish the Visual Arts History Lab in the Ritter Art Gallery.
 - Incoming artwork valued at \$1M+, a gift pledge to establish a \$75,000 endowment, and other funding to construct a base for an outdoor sculpture including moving and installation
- **Gifts also to the Jean A. and William J. Cruise Public Ethics Academy Fund:** located with the School of Public Administration
