### PROPOSED BOARD ACTION

Approve the election of the following new board members to the Florida Atlantic University Foundation Board of Directors: Zach Berg '97, '00, Ettore Ventrice (*Limited Purpose*), Michael Yoon '96, and Thomas Zeichman '09.

### BACKGROUND INFORMATION

#### Purpose of Action:

Per Florida Statute 1004.28(3), except for the directors appointed by the Chair of the University's Board of Trustees or designated by the University President, the University Board of Trustees approves all appointments of directors to the boards of directors of the University's direct-support organizations, including the Foundation. These proposed new Foundation Board members were unanimously elected for appointment by the Foundation's Board of Directors at its May 14, 2025, meeting.

**Zachary "Zach" Berg '97, '00** serves as partner and managing director of wealth management for G2G Wealth Management at Steward Partners since November 2024.
