SUBJECT: REQUEST FOR APPROVAL OF DEGREE TERMINATIONS: BA IN FRENCH, BA IN SPANISH, BA IN LINGUISTICS

#### PROPOSED COMMITTEE ACTION

Request for approval to terminate the Bachelor of Arts in French (16.0901), Bachelor of Arts in Spanish (16.0905), and Bachelor of Arts in Linguistics (16.0102) to roll up into the Bachelor of Arts in Language, Linguistics, and Comparative Literature (16.0101).

#### **BACKGROUND INFORMATION**

The Department of Languages, Linguistics and Comparative Literature currently offers undergraduate degree programs in French, Spanish, and Linguistics. The Department will roll all of the current stand-alone bachelor's degrees into a single degree program with four different concentrations. This change is consistent with the changes made at the graduate program level in 2016. The single degree program will be called a Bachelor of Arts in Language, Linguistics, and Comparative Literature (16.0101).

#### IMPLEMENTATION PLAN/DATE

The termination of the individual degree programs and the roll up into the new Bachelor of Arts in Languages, Linguistics and Comparative Literature will be effective Fall 2018. Students will be notified of a teach-out plan and expected to finish by Fall 2018.

#### FISCAL IMPLICATIONS

The courses required in the umbrella degree program are the same courses required in the individual degree programs. Therefore, the loss of the individual degree programs will not result in a loss in faculty, courses or other resources.
