**SUBJECT: PROPOSED NEW REGULATION 8.007—DETERMINATION OF FLORIDA
RESIDENCY STATUS FOR TUITION PURPOSES**

PROPOSED COMMITTEE ACTION

Recommend approval of new University Regulation 8.007--Determination of Florida Residency Status for Tuition Purposes

BACKGROUND INFORMATION

Regulation 8.007 was developed in accordance with Board of Governors Regulation 7.005, Residency for Tuition Purposes and section 1009.21, Florida Statutes. This new university regulation includes: (a) the requirement for each admitted student seeking to declare residency for tuition purposes to submit a residency declaration and the supporting documentation required, (b) the right of the university to establish submission deadlines, (c) a requirement for written notice to admitted students that the burden of providing clear and convincing documentation to justify the institution's classification of a student's residency status for tuition purposes rests with the student or, if the student is a dependent, with the student's parent or legal guardian, (d) the right for the university to request additional documentation, including documentation required to review an admitted student's citizenship status, (e) the requirement for the university to ensure that the student, parent or legal guardian has resided in Florida for at least twelve (12) consecutive months immediately preceding the term in which the student is seeking residency classification, and their purpose for residence in the State shall not be solely for the purpose of pursuing an education, except as otherwise provided in section 1009.21, Florida Statutes, and (f) a requirement for written notice disclosing the penalties for intentional fraud or misrepresentation of the student's residency status.

IMPLEMENTATION PLAN/DATE

The new regulation will become effective immediately upon adoption by the Board of Trustees.

FISCAL IMPLICATIONS

Establishes consistent policies across the State University System for the classification of students as residents for tuition purposes.

Regulation 8.007 Determination of Florida Residency Status for Tuition Purposes

(1) Purpose

This regulation establishes standards for determining each admitted student's Florida residency status for tuition purposes in compliance with Section 1009.21, Florida Statutes, and Florida Board of Governors Regulation 7.005.

(2) Residency Declaration and Required Documentation

- a. All students admitted to the University seeking to declare residency for tuition purposes must complete a Residency Declaration with supporting documentation required by the University to establish Florida residency for tuition purposes.
- b. Each student, or their parent or legal guardian if the student is a dependent, bears the burden of submitting clear and convincing documentation sufficient to justify classification as a Florida resident for tuition purposes. A student initially classified as a non-resident may request reclassification by submitting a new Residency Declaration and providing clear and convincing documentation to support the reclassification request.
- c. For documentation to be clear and convincing, it must be credible, precise, and compelling enough to persuade the University that the student or, if that student is a dependent, the student's parent or legal guardian, has established legal residence in Florida for at least twelve (12) consecutive months immediately preceding the first day of classes of the term for which residency classification is sought, and that the primary purpose for establishing such residence was not solely to pursue an education.
- d. The University shall provide admitted students with written notice that the burden of establishing eligibility for classification as a Florida resident for tuition purposes rests with the student, or if the student is a dependent, the student's parent or legal guardian.
- e. The University reserves the right to request additional documentation as necessary to make a proper residency determination pursuant to Section 1009.21(3), Florida Statutes, and BOG Regulation 7.005, including documentation required to evaluate an admitted student's citizenship status, where applicable, pursuant to Section 1009.21(2)(d), Florida Statutes.

(3) Notice of Penalties

- a. The University shall provide the student with written notice disclosing the penalties for intentional fraud or misrepresentation in connection with residency classification.
- b. Submission of false or misleading information regarding residency status may result in University action, including, but not limited to, reclassification of residency status, retroactive assessment of tuition and fees, and referral to the Dean of Students Office for disciplinary action, as applicable.
- c. In addition to University action, intentional fraud or misrepresentation of residency status may subject the student or, where applicable, the student's parent or legal guardian, to criminal penalties under Florida law including those provided in Sections 775.082 and 775.083, Florida Statutes.

(4) Submission Deadlines

- a. The University has the right to establish reasonable deadlines for submission of all documentation required to determine residency for tuition purposes. Deadlines for submission of documentation related to residency classification shall be published on the University's Residency for Tuition Purposes website and/or communicated to students through admission, registration, and onboarding materials.
- b. Students are responsible for complying with all established deadlines. A student who fails to submit required documentation by the applicable deadline for a given semester shall be classified based on the information available at the time. Such failure does not preclude the student from submitting a timely request for residency reclassification for a subsequent semester.

(5) Residency Appeals

The University's residency appeal process is set forth in the University Catalog and is prominently published on the University's website through the Office of the Registrar. Florida Atlantic University Residency Appeal Procedures are available at <https://www.fau.edu/registrar/residency/appeal/>.
