Veterans Out of State Tuition Waiver	Pursuant to Florida Statute 1009.26 (12)(a), and the federal Veterans' Access to Care through Choice, Accountability, and Transparency Act of 2014 (Title VII, section 702), the University shall waive out-of-state tuition and out-of-state financial aid fee for an honorably discharged veteran of the United States Armed Services, the United States Reserve Forces, or the National Guard who physically resides in Florida while enrolled in the University.
