AVAILABLE PAYMENT OPTIONS

Online Payment:

Online payment may be made until 5PM using the following options:

1. Credit Card: FAU accepts credit card payments through PayPath within FAU Self Service. PayPath accepts Visa, Discover, Mastercard and American Express. *

*The credit card option allows students to pay institutional and non-institutional charges on their accounts and are subject to a non-refundable service fee of 2.95% (\$3.00 minimum). The fee is charged by TouchNet Pay Path, not FAU.

2. Electronic Check: using a personal checking or savings account, at no additional fee.

There is no additional fee to initiate a payment using the electronic check option. Please be sure you have valid account information for a personal checking or savings account. You will need a valid account number for a checking or savings account AND the bank's routing number to complete payment. Please be advised, if your payment is submitted from a checking or savings account online, the payment is subject to final processing and approval by your bank. NOTE: By remitting your check payment by mail, you are authorizing FAU to electronically process your check. The electronic debit to your checking account may be on the same day your check payment is processed.

CANCELLATION OF REGISTRATION

If you are enrolled in Fall term P0 and you have not paid your tuition and fees in full by August 16, 2023 your registration will be cancelled by 5pm on the applicable date. If you are enrolled in Fall term P1 and/or P2 and you have not paid your tuition and fees in full by August 30, 2023 your registration will be cancelled by 5pm on the applicable date. If you are enrolled in Fall term P3 only and you have not paid your tuition and fees in full by October 25, 2023 your registration will be cancelled by 5pm on the applicable date. The cancellation EXCLUDES students deferred by Financial Aid, VA, State Mandated/Departmental Waiver or Florida Prepaid. Reinstatement requires full payment of all tuition and fees immediately, plus a \$100.00 late payment fee and a \$100.00 reinstatement fee. Reinstatement also requires an appeal to be filed with the Registrar's Office.

FLORIDA PREPAID AND OTHER FEE DEFERMENT INFORMATION

Florida Prepaid will be billed after drop/add. You will be notified via FAU email when your Florida Prepaid payment has been received. Please see: https://www.fau.edu/controller/student-services/prepaid/

Reminder: If you do not want Florida Prepaid to be billed, you must submit the following form to the Controller's office prior to the end of the drop and add period of each semester. Please see: Change in Billing Form

Third Party: If all or part of your fees are to be paid by a company or other organization, you must contact a representative of the Controller's Office on or before the Last Day to Pay, no later than 5pm. Proof of registration and an authorization to bill the company or other organization must be provided. If you fail to pay any amounts that you are responsible for by your scheduled due date of October 27, 2023, you will be assessed a late payment fee of \$100.00. Also, if the company or other organization does not pay their amount, you will be held responsible for that balance. Please see: https://www.fau.edu/controller/student-services/third-party-billing/

V.A. Deferments expire October 27, 2023. The payment deadline for all veterans who have deferred their fees is also October 27, 2023 by close of business at 5 pm, or online by 5pm. Non-payment by this date will result in late payment fees and/or reinstatement fees.
