NOTE: By remitting your check payment by mail, you are authorizing FAU to electronically process your check. The electronic debit to your checking account may be on the same day your check payment is processed.

CANCELLATION OF REGISTRATION

If you are enrolled in Summer term P0 and you have not paid your tuition and fees in full by **May 8, 2024** your registration will be cancelled by 5pm on the applicable date. If you are enrolled in Summer term P1 and/or P2 and you have not paid your tuition and fees in full by **May 22, 2024** your registration will be cancelled by 5pm on the applicable date. If you are enrolled in Summer term P3 only and you have not paid your tuition and fees in full by **July 3, 2024** your registration will be cancelled by 5pm on the applicable date. The cancellation **EXCLUDES** students deferred by Financial Aid, VA, State Mandated/Departmental Waiver or Florida Prepaid. Reinstatement requires full payment of all tuition and fees immediately, plus a \$100.00 late payment fee and a \$100.00 reinstatement fee. Reinstatement also requires an appeal to be filed with the Registrar's Office.

FLORIDA PREPAID AND OTHER FEE DEFERMENT INFORMATION

Florida Prepaid will be billed after drop/add. You will be notified via FAU email when your Florida Prepaid payment has been received.

Third Party: If all or part of your fees are to be paid by a company or other organization, you must contact a representative of the Controller's Office on or before the Last Day to Pay, no later than 5pm. Proof of registration and an authorization to bill the company or other organization must be provided. If you fail to pay any amounts that you are responsible for by your scheduled due date of **July 22, 2024**, you will be assessed a late payment fee of \$100.00. Also, if

the company or other organization does not pay their amount, you will be held responsible for that balance. Please see:
