### Dr. Maysaa Barakat




Dr. Barakat is a full professor and distinguished educator with a passion for academic and professional excellence, commitment to social justice and inclusion, community engagement, and international mindedness.



### The Dissertation (minimum of 20 credits)



From Day 1 students begin to work on creating a Concept Paper that will be the backbone for their dissertation.



By the end of their required coursework, they submit the Concept Paper which serves as the Qualifying Exam.




Upon passing the Qualifying Exam, students then become candidates and work with their Dissertation Chair and Dissertation Committee members to create their Proposal.



Once the Proposal is accepted by the Committee, the candidate then conducts the study outlined in the Proposal.



Once the research is completed, the student submits and defends their Dissertation.



### General Admission Requirements

- Minimum graduate GPA of 3.0 (Master's or Specialist Degree)
- Demonstration of scholarship skills and practices through writing and references
- If invited after first review, strong interaction during the interview process
- **Note**: Meeting the minimum admission requirements does not guarantee admission to the program

### Application Process – Part 1

### Prepare and submit online:

- Personal objective essay that:
  - identifies your career goals
  - demonstrates graduate level writing
  - makes evident your area of interest: what is my leadership research goal?
  - discusses how the School Leaders PhD will enable you to meet these goals
- Professional résumé
- Names and emails of three references (especially from scholars and people who can evaluate your work as a researcher/writer/professional)
- Your email address (must have one upon entering the program)

### Admission Process

- March 1<sup>st</sup> is the deadline for Fall admission. However, understand that cohorts fill on a first come and first admit basis.
  - Online application completed
  - Application fee paid
  - Official transcripts received by Graduate College
- Upon receipt of completed application:
  - Committee reviews completed applications that meet the minimum requirements
  - Individuals whose applications received a favorable review are invited to an interview
  - Prompt for writing sample is sent via email the day before your interview

### **Estimated Current Costs**

- Currently, a total of 60 credit hours will cost approximately \$22,309.20.
- The average number of credit hours per semester is six, so on average you will be paying (not counting other fees and textbooks) \$2,230.92.
- The estimated cost of 20 credit hours for dissertation is \$7436.40.
