ROLES, RESPONSIBILITIES & INITIATIVES

Assistant Provost for eLearning Florida Atlantic University 2013 to 2019

Member of the academic leadership team at a public university with 30,000+ students and 828 faculty. As assistant provost, I provide vision and strategic direction for the delivery of distance education at the university for 5 colleges; leadership to the Center for eLearning; management of the design and development of online courses, management of online degrees, oversight of online student support services, designed and implemented social media marketing campaign, provide professional development for faculty, represented Florida Atlantic University on state committees, and support for online continuing education programs.

- Leadership for distance education: Led organizational change as the university accepted distance learning as an option for delivery of instructional content a contributing factor in the improved university performance. To accomplish that goal, leadership provided to the colleges resulting in 17,000 students taking at least online class reducing the time to graduation within the bachelor programs with 3500 of those students taking only online classes, expanding the online degree program options from 5 to 40+ including bachelor's degrees, master's degrees, and certifications; increasing student satisfaction and ratings of quality by a significant difference based upon improved course design and training of instructors over previous course design techniques and training; and launching of student communities of practice for online degree programs for higher rates of student engagement;
- Management of the design and development of online courses: The management of a 30+ team which supports faculty in the design and development of courses using a variety of technology tools including developed video, multimedia, and web-based instruction; ensuring all online instruction that meets the American Disabilities Act compliance standards; creating and implementing program evaluation and quality control measures in the migration of degree programs to online and the development of online courses; and decreased time from conceptualization to the delivery of instructional products using cognitive scaffolding and rapid prototype design techniques from 18 months to 4 months. The processes yield results in high levels of productivity developing over 100 courses annually and migrating highly rated degree with top 30 best in online programs identified by U.S and News and World Report and Best in Online programs.
- Oversight of online student support services: Provided student support services for over 17,000 students to ensure success in the distance learning courses. The goal of the online student support

- services was to ensure equivalent access to service provided to on-ground services. To accomplish this goal, online student advisor and online student support advisory councils were formed to support the staff.
- Created social media marketing campaign: Developed a marketing campaign which combined web presence, social media, YouTube, Facebook, Google, billboards, movie theater ads, and traditional print media to increase the number of hits to the website by from 3600 to 17,200 page-views per month. In 2017/18 academic year 1500 students began their academic career at FAU fully online.
- Representing Florida Atlantic University on statewide committees: The work of the statewide committees influenced legislation and changes in regulations governing the state university system. Among the many projects the I lead on behalf of the statewide leadership team or I was a member of the team included the development of a statewide online education strategic plan; development of whitepapers on technology access in Florida and accelerated degree options; a statewide cost analysis for the design, development, and implementation of online degree programs; the development of the Online Student Support Scorecard to evaluate the availability of the online support services which was adopted by Online Learning Consortium included into its suite of scorecards for evaluation of quality distance education; and online readiness survey and orientation.
- Guided other initiatives on campus including a partnership with the library to promote affordable
 curriculum for students by awarding affordability seals to instructors with \$60 or less per course
 and free to student integrated into the course schedule system. Also, included institutional grants
 to promote modification of OER textbooks, creation of ancillary materials, and authoring of
 eTextbooks. Also, put in place several strategies to increase graduation rates and decrease time to
 graduation.
- Other management duties included turning a \$700,000 deficit budget into a positive with increased income for the university to \$36+ million annual income in tuition and fees overall income from distance learning, leading research and grant writing efforts by the Center for eLearning, designing classroom settings to meet the content area needs, supporting the Provost Office in efforts related to SACS-COC accreditation and other college accreditations, and serving on committees to prepare annual reports for the Florida State University System Board of Governors.
