Welcome:

Discussion regarding number of representatives---for the Dept. of Curriculum/Instruction to be added to the agenda. A motion to approve minutes was brought forth by Scott. Revisions to the minutes were made to add detail regarding the SPOTs.

A discussion regarding SPOTS for smaller classes, clinical courses, and student teaching and internship was held. Faculty felt that the feedback would be helpful—either qualitative or quantitative. This feedback would not necessarily be used for promotion and tenure purposes.

A suggestion to use LiveText to get the data from the courses, internship, and clinical experiences before requesting from University IEA. It was suggested to put this under “new business” at the next FA meeting. The item would be suggested at the next FA. It would have to go up for a vote in the Fall to be implemented. The idea is to put a survey, developed by some faculty from EDLRM, to post on a Canvas shell, into the class only. It was also discussed that there is an option for an anonymous discussion in Canvas. There was a question about whether it needs to be uniform. It was suggested to ask for (1) qualitative information from IEA and (2) create a uniform survey for the COE for lower number classes, practicum, internship, and clinical courses.

A motion to approve the minutes with revision by Ramirez. Finnegan second. All were in favor. Minutes from 1/2022 were approved.

Announcements for the FA were decided upon which includes awards and faculty that were recently promoted/tenured would be announced.

A discussion regarding bargaining occurred. It is important for faculty to attend the next bargaining meeting.

There was a question regarding FA budget items. In addition, it was discussed to have some type of policy regarding sending flowers, etc. for bereavement for faculty members.
