The undergraduate ESE program is a limited access, single entry point program. That is, students begin the sequence of ESE courses in the fall semester of their junior year and complete the program at the end of the spring semester of their senior year (5 semesters). Accordingly, undergraduate ESE courses are offered once a year. If you do not follow the sequence of ESE courses listed, you will fall behind by at least one entire year.

Getting Programmed

Three conditions must be met before you will be accepted into the College of Education:

- Present passing scores on all sections of the CLAST or, if exempt from the CLAST, present passing scores on all sections of the General Knowledge (GK) test,
- 2. have a GPA of 2.5 or higher, and
- 3. receive an official letter of acceptance from the College of Education.

Once these conditions have been met, you will be assigned an advisor in the Department of Exceptional Student Education who will officially develop your Program of Study. At that time you and your advisor will review the courses, discuss field experiences, and develop a projected sequence of courses for you.

YOU MUST BE PROGRAMMED PRIOR TO REGISTERING FOR THE SPRING SEMESTER OF YOUR JUNIOR YEAR, OR YOU WILL NOT BE ALLOWED TO TAKE THE SPRING SEQUENCE OF ESE COURSES. It is your responsibility to contact your assigned advisor to set up an appointment to be programmed. You and your advisor will complete a program form that includes the specific courses you will need to graduate. After final approval, a copy of the program is given to you, another is kept on file in the ESE Department, and another is sent to the Office of Academic and Student Services. This is your contract with the ESE Department. To graduate, your transcript must show grades of "C" or above in all Education courses included on the program. You also must maintain an overall GPA of 2.5 and meet other professional development requirements.

At the time of programming you will be asked to disclose whether you have ever been convicted of a misdemeanor, felony, or any criminal or civil offense other than a minor traffic violation, or whether you have been found guilty of personal conduct which could reduce your effectiveness as a teacher. This disclosure does not automatically exclude you from the program; however, it is essential to disclose and discuss possible effects on your ability to complete the degree program. Failure to disclose this information will be considered disruptive conduct as defined in the FAU Student Handbook.

Program Requirements

General Education requirements typically are met in lower division courses and determined upon admittance to the College of Education. In addition, a **minimum** of 66 hours of FAU coursework is needed to fulfill University, College of Education, Teacher Certification and ESE Department requirements. **Many of these courses must be taken in a specific sequence**; therefore it is very important that you familiarize yourself with the program and stay in touch with your advisor. In general, the program consists of requirements within the following College of Education departments: Instructional Technology and Research, Teacher Education, and Exceptional Student Education.

Before you enter the programmed ESE bachelor's degree sequence, you must complete:

- EDF 2005: Introduction to Education;
- EDG 2701: Teaching Diverse Populations;
- EME 2040: Introduction to Educational Technology; and
- Lower division core courses or complete an AA for Education transfer at the community college.

Once you begin your programmed ESE bachelor's degree sequence, you will enroll in Professional Education Courses (taken by all FAU teacher education students) and courses specific to ESE. The following Program of Study shows the basic list of courses and the course sequence.

Recent changes in teaching certification standards require that ESE teachers in Florida become "Highly Qualified" by adding a subject area certification beyond their ESE certification. For teachers planning to teach elementary aged students with disabilities, certification in Elementary Education is appropriate. For middle or secondary ESE teachers, the Middle Grades Integrated Curriculum certification, or certification in a Secondary content area (e.g., Biology, Math) is preferred. While students can earn these additional certifications by taking a Subject Area test on the FTCE, others might wish to take additional courses prior to passing the exam. If you wish to take additional coursework in Elementary Education, your transcript will be evaluated on a course-bycourse basis. Typically, the following courses are appropriate for Elementary Education. However, these requirements are subject to change, so you should contact the Office of Academic and Student Services (OASS) at FAU or the Teacher Certification Office of the Department of Education in Tallahassee at 1-800-445-6739 or on the web at www.fldoe.org for current certification requirements.

ESE teachers who wish to teach regular academic courses in middle or high schools will also require individual transcript evaluations.

Practicum and Student Teaching

During the fall semester of your senior year, you will enroll in two ESE courses and a field-based practicum. The practicum requires a minimum of 9 hours a week, 3 days a week in a school setting. This field experience, combined with your ESE coursework will prepare you for student teaching. Practicum is <u>only</u> offered during the fall semester.

Student teaching in ESE is offered only in the Spring semester. Applications are available on-line at http://www.coe.fau.edu/OASS/TO%20DELETE/studteach%20.htm. Specific due dates are outlined in the College of Education section of the University Catalog. Your student teaching application must be reviewed, approved, and signed by your advisor prior to the submission deadline. It is your responsibility to make an appointment with your advisor well in advance of the due date to allow the advisor sufficient time to review your application for correctness and content, and request changes as necessary before signing it. You should be aware that each school district has additional requirements and associated fees for background checks, fingerprinting, drug screens, etc. These requirements are listed on line at http://www.coe.fau.edu/OASS/field.htm and are your responsibility to complete.

Critical Assignments and Florida Educator Accomplished Practices

The Florida Department of Education has identified a set of Accomplished Practices that must be mastered in order to continue in the ESE Bachelor's Degree Program. The twelve Educator Accomplish Practices are part of the accreditation process for all Colleges of Education in Florida. Each Accomplished Practice is connected to a critical assignment in the ESE course sequence, and these critical assignments are identified in syllabi of ESE courses.

ESE Department Policy on CRITICAL ASSIGNMENT(S)

Students must earn a **minimum grade of 73%** of the points allotted for the Critical Assignment to receive a passing grade of C or better in this course. In other words, a student cannot pass the course with a C or better without successfully completing the Critical Assignment.

Remediation policy:

- If a student is passing the course with a C or better, but has failed to pass the Critical Assignment with a minimum of 73% of the possible points, the student will receive an "INC" in the course until the Critical Assignment is successfully redone (only one attempt allowed). The conditions and time frame for the resubmission of the assignment will be determined by the instructor. However, the second attempt must be completed within one semester. Upon successful completion of the resubmitted assignment, the "INC" will be changed to a grade for the course and the student may continue in the ESE sequence of courses. The original points earned for the initial attempt at the Critical Assignment will be used to calculate the final grade in the course. If the resubmitted Critical Assignment is not successfully passed, the grade for the course will be C- or below based upon the total points earned.
- If a student is not passing the course with a grade of C or better, and
 has failed to pass the Critical Assignment with a minimum of 73% of the
 possible points, the student will <u>not</u> be allowed to resubmit the Critical
 Assignment. The student will need to repeat the course <u>and</u> the Critical
 Assignment.

Florida Teacher's Certification Exam (FTCE) and General Knowledge Test

Students in the ESE program are required to take and pass the Professional Education and Subject Area exams **before being cleared for graduation**. The Professional Education test measures basic educational knowledge, theory, and practice. The Subject Area test that is required prior to graduation is specific to the ESE program and measures knowledge of theory and practice related to teaching students with disabilities. The Department also *strongly encourages* students to take and pass the
