PROJECT DESCRIPTION

Projects included in the scope of this agreement will be specific for renovations, alterations, and additions and/or repairs of FAU facilities; including infrastructure and utilities projects that have a basic construction budget estimated to be \$2,000,000 or less, or studies for which the fee for professional services is \$200,000 or less. Services may be utilized on all FAU Campuses, special purpose centers/sites and instructional sites on an as needed basis.

SELECTION CRITERIA

Firms will be evaluated in the following areas: current workload, location, past performance, volume of state work, design ability, and experience and ability. Experience and ability scores will be based on the following criteria:

1. Experience of firm and individual members of the design team with project of similar size and program.
2. Experience of firm and individual members of the design team in working with the State University System.
3. Evidence of efficient contract administration of projects.
