

Course Description

This course provides an overview of data engineering and data science for students with no prior experience in computer science or programming. The topics include data cleaning, ETL (extract, transform, load) pipelines, databases, exploratory data analysis, data visualization, and introductory machine learning. By the end of the course, students will have a foundational understanding of how data drives decision-making in various fields and get hands-on skills to solve real-world challenges using a low-code environment. Students may not enroll in CAP 5796 if they have already taken CAP 4790.

Instructional Method

This class is designated as "In-Person w/Recorded Lecture" (section XXX) or "Videotaped Class" (section YYY). In-person class sessions will be automatically recorded and uploaded to Canvas within 24 hours. Student enrolled in section XXX may choose to attend in-person classes or view recordings, whereas students enrolled in section YYY are only able to view recordings.

Graduate standing.

Course Objectives/Student Learning Outcomes

By the end of this course, students will:

- Understand the roles of data engineering and data science in the data ecosystem.
- Learn the basics of data collection, transformation, storage, and visualization.
- Develop foundational skills in exploratory data analysis (EDA) and machine learning.
- Build and present a small project combining data engineering and data science concepts.
