 - a. William Kalies: This program needed a plan and the committee decided that this program would merge with Applied Mathematics degree and offer different concentrations. The intent would also be to terminate the Applied Mathematics and Statistics program.
 - b. Chris: The two (2) Program Change cover pages should be amended by removing the word "Combined" from the Program Name and only reference the individual programs themselves. Also, reverse the order of the cover pages so the program being terminated is second.
 - c. Brian Hodge: Is intent to have "Concentration" listed on the diploma/transcript?
 - i. William: Yes, that is correct.
 - d. Motion and second to approve, as amended.

 - c. Lisa Dario: Any requirement to make this permanent by the individual departments/programs?
 - i. Chris: No, not at the present time.
 - d. Motion and second to approve, as is.
 - e. Approved, as is.
- V. Additional Discussion Items
 - A. Fully Online Program Review Discussion
 - 1. Chris: There is a current program, delivered in face-to-face mode, that wants to also have a fully online version with no other changes other than the mode of delivery. Would something like that need to come before this committee?
 - a. Eric Berlatsky: I don't believe this has ever been a requirement or the purview of this committee. I don't even know that we would be reviewing or considering! I don't think we should get involved.
 - b. Deb Szabo: This is now a sub-policy with SACS so you should reach out to Russ Ivey for clarification.
 - c. Art: Mode of delivery has always been a "faculty decision". This committee would be over-riding that faculty in that case.
 - d. Eric: Not exactly correct. Administrators make the schedule, not faculty. They then notify faculty as to the mode of delivery.
 - e. Brian: In conversation with Dan Meeroff & Chris Beetle it was felt this did not rise to the level of consideration by GPC. Chris just wanted to bring this before the GPC to see if anyone had any objections.
 - f. Paul Peluso: Will SACS require, via COCE, some kind of notification?
 - ii. Deb: Yes, SACS will need some kind of notification when this happens.
 - g. Eric: Historically, departments could run courses online without COCE approval/consideration. This might be a good thing to have a discussion about with faculty governance going forward.

- h. Chris: I would like to get a motion for a resolution that programs being offered online, with no changes to content, do not need to come before this committee.
 - i. Motion and second
 - ii. Approved
- i. Chris: There is a "rumor" that this may become a requirement of COCE/SACS in the near future.
- j. Paul: What if COCE were to submit a list of courses, monthly or whatever, to GPC for consideration to see if there are any objections? Concerned with faculty not having any role in this.
- k. Art: Some things don't translate well from one mode of delivery to another.
- 1. Eric: They tend to push things that are asynchronous. Many disciplines require interactions that cannot be done in an asynchronous manner.
- m. Art: In an asynchronous environment, some things get lost in the translation...no matter how many times they are discussed and/or explained!
- n. Deb: Posted wording directly from SACS: Anytime a program is offered 50% or more in a specific manner, it requires notification to SACS. If you plan to continue offering in a given manner, you must notify SACS.
- Chris: The bottom line, if there are questions, it might be a good idea to bring before faculty governance to discuss further. Ultimately, this decision should come from faculty with governance guidance, if necessary.
- p. Chris: The members of this committee should probably mull this over and come to next month's GPC meeting for further discussion. Add this as an agenda item for next month's meeting.
