 - 2. Discussion of Undergraduate Enrollment in Graduate Courses: Registrar
 - a. Brian Hodge: Explained that the policy, as written, cannot be enforced because there are no registration restrictions on 5000 level courses (restrictions are applied to 6000 level courses). Shared a case example of a student who did poorly in a 5000 level course and wanted a late academic withdrawal without penalty—the student claimed that because registration was not restricted and the policy was not enforced, the student should not be held accountable. Discussion followed:
 - i. Mihaela Cardei: explained an example case where a first year student enrolled in a 5000 level course without speaking with an advisor. Mihaela stated that as a result it would be important to understand registration restrictions and the petition process.
 - ii. Brian Hodge: explained that registration restrictions can be made using the fields of student classification (i.e. freshman, or junior standing), course level, program, and college. Brian will confirm the full list of fields and send to the group.
 - iii. Bill Kalies: explained that in COS there is an increased number of advanced students that will need to take GR level courses early. Bill proposed a less rigid and efficient structures, but one that still allows for advising intervention.
 - iv. Art Sementelli: inquired if registration could be restricted on GPA.
 - v. Brian Hodge: confirmed that Banner cannot restrict on GPA.
 - vi. Eric Berlatsky: inquired about tuition cost- it was confirmed that all GR level courses are charged at the graduate rate, even if taken during an undergraduate program.
 - b. Next steps: Brian Hodge will review policies at other institutions. Members were asked to review the policy and provide feedback at the next UGPC meeting.
