 2. Beth King: Had questions about some of the other CCR's and how they relate to the Provost's memo regarding Course Changes.
 3. Beth: Questions about Disability Statement in the syllabi for the CCR's. Worded as "Assistance and Accommodations" rather than the standard boilerplate language.
 4. Beth: PAD6701: Pre-req is missing from the syllabi. Should specify no pre-reqs in syllabus.
 5. Beth: Use the term "course resources" rather than "textbooks".
 6. Chris: I don't think we need to get that granular for this committee's purposes.
 7. Chris: Cannot require students to download Adobe Flash Player which has been deemed to be a disaster.

 - b. Chris: Appearance of text needs to be cleaned up. Catalog language s/b redlined, similar to other catalog changes in the past.

 - ii. Chris/Brian: This item should probably be stricken from the document. Copy should go to UUPC for their information as the change pertains to U/G coursework.

 - a. Brian: Do you want “Fin Tech” in the title?
 - i. Anita will check and let everyone know.

- b. Tamara: Joint between Finance and ITOM. Students must have experience, coursework, background in both. “Fin Tech” is used by many other institutions and should be included. She would rather see “Financial Technology” removed and call it “Fin Tech” Graduate Certificate.
 - c. Chris: Having both is redundant, imho.
 - d. Anita: Will discuss with Doug and get back to the committee.

10. Anita: All remaining items are related to self-sustaining programs.
11. Vegar Wiik: 3 Masters and 3 Certificates all utilizing existing courses. Geared toward the working professional who would like to further their education with a certificate or Master’s degree.
- a. Art: There was talk a few years ago to ensure that self-sustaining programs weren’t drawing students away from the regular programs. Separate sections of the courses are required.
 - b. Vegar: Goal is to maintain both with minor differences like scheduling.

 - iv. Brian: We want to keep it consistent with others like this.
 - v. Chris: Tweak language to state, "COECS is proposing a self-sustaining version of its existing program in..."
 - vi. Motion and second for approval as amended.
 - vii. Approved as amended.
 - b. Professional Energy Resilience Certificate
 - i. Chris: Make correction, the same as "v" above.
 - ii. Motion and second for approval as amended.
